## ***ASSOCIATE MEMBERSHIP CRITERIA***

The following is edited from the Federation Bylaws.

### **A. ASSOCIATE MEMBERSHIP**

1. Associate membership is open to any interested individuals or organizations, including commercial establishments, federations, or out of state organizations, who are interested in supporting folk dancing.
2. Associate membership does not include voting privileges at Federation Council meetings.
3. Associate members are not covered by Federation insurance.
4. Associate members may receive copies of minutes of Federation Council meetings upon payment of a nominal fee to cover costs.

### **B. INITIAL QUALIFYING PROCEDURE**

1. The interested party must submit all completed required forms along with a check for the fee to the Treasurer.

### **C. INDIVIDUAL, ORGANIZATION, AND HONORARY MEMBERSHIP CRITERIA**

1. Individual Associate Membership: Open to any interested individual regardless of race, color or creed.
2. Associate Organization Membership: Open to any organization interested in supporting folk dancing.
3. Honorary Associate Membership: Special Honorary Memberships may be awarded by action of the Federation Council. In addition, all Past Presidents of the Federation shall be Honorary Associate Members. Honorary Associate Members are exempt from paying Associate Member fees and shall receive minutes of Federation Council meetings upon request.
