Working Together To Ensure Safe, Healthy, **Memorable Proms and Graduations**

Most students and their parents make healthy decisions to ensure the enjoyment of proms and graduation. Principals and other school personnel have supported their end of year celebrations by encouraging students to avoid the use of alcohol, other drugs, or other risky or potentially destructive behaviors. Alcohol vendors take precautions so that persons under 21 do not make illegal purchases at their establishments. Police departments work hard to keep our road safe from alcoholimpaired drivers of all ages. Hotels want to ensure the safety of their guests, whether in a function room, overnight accommodations other or locations on their property.

Pulling Together

In order to help ensure a safe prom and graduation season, the GATHER/GTHHSC Substance Abuse Committee has sent letters, along with the dates and cities of each prom and graduation to police departments, liquor store owners and hotel managers, to ask their help in working together to safeguarding these exciting and memorable times for our young people and all those whose lives

they touch. Additionally, High School principals in the GATHER area (Attleboro, Berkley, Dighton, Lakeville, Mansfield, Middleboro, North Attleboro, Norton, Raynham, Rehoboth. Seekonk, and received Taunton) safety awareness letters suitable for sharing with parents of juniors and seniors.

Prom and graduation season lasts from April 1 – June 11, 2006, and area high school students are already enjoying prom and graduation time. Most high school students will continue to make healthy decisions. Parents and community members wish to do everything possible to support students to enjoy and celebrate safely and responsibly, without the use of alcohol, other drugs, or other risky or potentially destructive behaviors.

Concerns

Recent studies show that the major source of alcohol for vouth is friends and families. The increasing popularity of house, "tail-gate" and hotel room parties where underage drinking and other risky behaviors occur raises increased concerns for liquor store owners, school

officials, law enforcement and managers. Concerned hotel parents know they cannot give alcohol to their children's friends who are under the age of 21 under any circumstances, even in their own residence, even with permission of that child's parent. Parents may be held responsible if underage drinking occurs at their house or if a motor vehicle crash resulting in serious injury or even death occurs, involving someone who drank alcohol while at their home.

A New Danger

In an effort to provide a "safe" alternative to drinking and driving, some parents plan to reserve rooms for unsupervised after prom parties. GATHER area hotel managers were alerted to dates of area proms, and the following dangers and liabilities:

- > Occupation by many more than the allowable 2-4 occupants per room
- > Uncontrolled access due to unsecured doors
- > Underage alcohol abuse or overdose
- \succ Abuse of other drugs
- > Physical and emotional violence

Other dangers associated with risky behavior include these:

- Alcohol-related crashes remain a leading cause of death in this country, especially for teens.
- Long-term effects of alcohol-related damage incurred at a young age on a still developing brain
- Negative impact on educational success, social and family relationships, employment and legal issues

Teens need their parents to continue to set clear and realistic expectations regarding underage drinking. It is dangerous, it is against the law, and it should not take place. The GATHER community wishes to support and encourage them to continue to make healthy choices.

GATHER/GTHHSC Substance Abuse Committee. 3/15/06, 3:30, CCBC

Discussion Highlights:

School Drug Policies -Taunton's district wide policy is drafted and includes use of a breathalyzer test. The final policy will be read at 3 school committee meetings, and parents will receive letters. Once it becomes policy, staff will be trained. The policy will state purpose, what the school is trying to prevent and procedures.

After Prom Parties Awareness Campaign

Prom/graduation safety awareness letters were reviewed. Suggested recipients include GATHER area parents of juniors and seniors, hotel managers, liquor store managers and police departments.

- Press releases highlighting prom safety and liability will be sent to local newspapers, television, cable and radio. It will also be the topic of a local cable police show, presented by concerned high school students.
- Student volunteers will make follow up phone calls in June to access effectiveness for continuation next year.

Tobacco Mini-Grant Update -Two THS students attended advocacv training. Students brainstormed what they want to change, then wrote a petition, letter, and set up a meeting. A college leader works with students. Peers will meet to select a poster slogan based on a perception survey of students. Later, focus groups will discuss the message, and then posters will be printed and distributed. A new survey will be done on 4/25/06.

Area Practices – New Bedford's Students Assistance

Program is a voluntary random drug testing program. Parent orientations for understanding the benefits and limitations will be held this month. Participants will receive incentives and discounts from businesses, and parents and students will have a go to point for help with substance abuse issues. Parents will also receive information about how to talk to their kids If the discrete about drugs. saliva test is positive, parents are contacted and further follow up is provided. If negative, parents receive a congratulatory call. Students will receive a drug free employment card they can show employers. This first of its kind program in MA is open to the whole student body.

- > More Female Nonsmokers Dving of Lung Cancer -The same amount of tobacco exposure is more likely to lead to the changes that cause lung cancer in a than the male woman counterpart who gets the same secondhand exposure. About 15,000 nonsmoking women die of lung cancer annually. More women die annually from lung cancer than breast and ovarian cancer combined
- Taking It On Herself To **Sound A Warning** – Losing her boyfriend made Haley Cyr speak up about teen drinking. Last November 4, 2005, her boyfriend, who had been drinking wanted her to come with him to Wendy's. This time, she offered to drive, but when he repeatedly refused the offer and accused her of not trusting him, she walked away. He died in a crash as well as did a friend who accompanied him. Police are pursuing charges against a 17 year old and his mother for allegedly hosting a house party that day. Haley now shares her boyfriend's story at school assembly programs with other teens in hopes good thev will make decisions when it comes to alcohol. She feels personal stories carry more sway with

teens, especially girls, when they are told by other teens. She doesn't believe the story will stop teens from drinking, but hopes it will persuade some not to drive drunk or get into a car with a drunk driver.

From Tobacco in the News: Campaign for Tobacco-Free kids:

- Global Tobacco Treaty - \geq Government officials gathered in Geneva at the WHO for the first meeting of the ratifying parties of the Framework Convention on Tobacco Control, the global tobacco treaty that became law last year. The United States did not participate in any of the proceedings including those on key provisions smuggling important to the U.S. because it has not yet ratified the treaty. Although the Administration signed it in May 2004, it failed to send it to the Senate for ratification.
- Cancer deaths decline, but 1/3 of all cancer deaths remain attributable to tobacco use
- Internet Tobacco Sales -More than 500 internet websites sell tobacco products at lower prices, because they do not include excise or sales tax.

GTHHSC/GATHER Planning Meeting. 3/21/06, 9:00, Associates for Human Services

Discussion Highlights:

Purpose – Today's meeting is a continuation of the February meeting (See February 2006 Advocate, GTHHSC/GATHER Preplanning Meeting) discussion of how GATHER and GTHHSC operate both independently, and with the DPH as part of the CHNA system. Whether to combine, merge into one group, continue as is, remain separate and distinct, merge in a different fashion under an entity, or some other format, are all options.

Announcements: Emergency Task Force:

- \$2500 donation was received from Bay State Gas for the fuel fund
- There are 300 homeless individuals in the CHNA area
- A United Way grant was submitted, to help with emergency needs
- ETF worked on bylaws
- Fire Chief Rose attended the recent meeting

Domestic Violence – The Committee has funded а presentation of the dating violence awareness play "The Yellow Dress" to be held this Friday at T.H.S. for juniors and seniors. Press releases were distributed.

Substance Abuse Committee continues work on the prom safety project. GATHER area police, liquor establishments, hotels and parents will receive information in helping them to do their part in helping youth make healthy decisions, and have a successful prom season.

Comparison of GTHHSC and GATHER - Southeast Center for Healthy Communities facilitated the process considering structure and service to the 12 GATHER communities (Plainville is not part of GATHER).

- **GATHER:** Through the CHNA system, GATHER access DPH mav representation and technical assistance from SCHC. The DPH also requires agencies receiving their funding to attend the local CHNA. GATHER addresses needs and trends works in subcommittees, and is a state designated CHNA.
- GTHHSC was established to network and identify needs and trends, addressed by subcommittees who report back to the GTHHSC.

Geography: Both Attleboro and Taunton are separate cities, so a structure is needed to get programming in both, although many member agencies, as well as area committees, serve the entire GATHER area. Some of these include Community Care Services, WIC, DSS, New Hope, GATCH (Greater Committee Attleboro/Taunton on Homelessness), the new AIDS Consortium design. SEMA-VAV (Voices Against Violence) and Bristol Elder Services Both cities have

committees focused on basic needs: Emergency Task Force in Taunton, and Attleboro Area Council.

- GTHHSC Service areas reached through member agencies technically cover Attleboro, Berkley, Dighton, Lakeville, Middleboro, Raynham, Rehoboth, Seekonk and Taunton although representation is mostly Taunton.
- GATHER area additionally ideally includes Mansfield, N. Attleboro and Norton.

Programming - Most GTHHSC and GATHER programming is focused in Taunton. Awareness activities of the Substance Abuse committee covers all of GATHER.

Committees:

- GATHER Service Area The Substance Abuse Committee has a GATHER area programming focus.
- > Taunton Service Area -Committees with mostly a Taunton focus include the Child and Family Focus addresses full (also GATHER through area Advocate Newsletter inserts and articles). Domestic Violence Violence / Prevention, and Community Health and Wellness.

Structure – Fiscal management is different for each coalition. Both coalitions share the same administrative support through the coordinator.

- GATHER uses New Hope for fiscal management. It has a steering committee which meets quarterly.
- GTHHSC uses CCBC for financial management. The coalition has worked with the United Way on needs assessments, and uses these to address needs and establish both ad hoc and long standing committees.

Events – Both Coalitions share the Substance Abuse Round Tables, an Annual Meeting and the Advocate Newsletter. The annual meeting highlights accomplishments, and does not include strategic planning.

Funding: GTHHSC dues and part of the GATHER DON funding supports coordination of both groups.

 GTHHSC funding comes from dues and grant application \triangleright **GATHER** receives DON monies and applies for grants. Hospitals are supposed to pass DON monies to the local CHNA, which would be GATHER for both Sturdy and Morton. There is strong support from Morton Hospital, but none from Sturdy at this time.

Membership – The Coalitions wish to build active membership.

Development – A Coordination Committee with representatives from GTHHSC and the GATHER Steering Committee could engage both Attleboro and Taunton.

- To talk about next steps to develop CHNA #24 (GATHER) into a more accurate representation
- To work towards connecting Attleboro and Taunton groups
- To carry out yearly strategic planning

To create an operation that links communities, pools resources, needs, representation and allocate funding.

Next Steps:

Prepare for a larger Planning Meeting on 4/4/06, of GTHHSC and GATHER to include the GATHER Steering Committee, GTHHSC membership and all DPH mandated agencies from Attleboro and Taunton.
