Taunton Emergency Task Force

The Taunton Emergency Task Force (ETF) is a citywide organization that has been in existence since March 1985, and became incorporated in February Originally, this group 1995. came together through the efforts of several committed individuals who were interested in taking action to address and improve the affordable housing situation in the greater Taunton area. Founding members included Roland Ducharme [former] district president for St. Vincent de Paul and former ETF chairperson], Dick Johnson [former mayor of Taunton], Bob Cammarata, [director of the Taunton Department of Human Senator Services], Marc Pacheco, Paul Pagano [former director of United Way], Natalie Leckhart [concerned community representative]. Deb [director of the Taunton office of Citizens for Citizens and former ETF chairpersonl, and Anne Bagge [executive director of Triumph Head Start].

The Task Force has evolved over time and now includes a membership of over 40 organizations, businesses, city departments. churches and individuals. It is a non-profit, citywide task force represents local agencies dealing directly or indirectly with conditions that are detrimental to the health, safety or social well being of individuals and families in the Greater Taunton area. The Task Force draws upon all available resources to assist those in need, raising funds and materials to accomplish this. It is not the intention of the Task Force to compete with existing services. Rather, the group

strives to supplement existing services in its approach to solving problems with those in emergency-situations. This spirit of cooperation amongst the member agencies is unique in Southeastern MA. The current officers are: Milly Burrows. chairperson; Julia Wood, vicechairperson, Charlene Sanger, treasurer; and Donna DeFaria, secretary. The ETF meets on the first Tuesday of the month at the GATRA Administration Building conference room. interested Anyone in membership may call Donna DeFaria, 508 822-0051.

During 2005, the Task Force assisted individuals 517 representing 258 families. total of \$ 25,606.95 was expended to help alleviate emergencies in the following areas: rental assistance, fuel assistance, non-heat related utilities, long distance and fixed bus route transportation, and childcare arrearages. Funding has been made possible by charitable donations, the United Greater ofWav Attleboro/Taunton, Bristol County Savings Bank Charitable Foundation, and the First Annual Warm Homes for the Holidays led by Senator Marc Pacheco, Representative James Fagan and the owners of Bella Roma Restaurant.

In addition to the monthly meetings to address issues in the area, the Task Force currently has three financial programs available for citizens in the area. The Community Impact Emergency Fund and the Fuel Assistance programs are offered to citizens in Taunton, Raynham, Berkley and Dighton. The fixed

bus route transportation program is offered to residents in Taunton All three programs are unique regarding their guidelines. programs All facilitated by the Taunton Emergency Task Force are available subject to funding availability. Intakes for all programs are by appointment only.

- > The Community Impact **Emergency fund** addresses rental. non-heat related utility (excludes cable and telephone), long distance transportation and childcare arrearage emergencies. agency referral is An required. This program offers up to \$200.00 in assistance in the above areas on a first come, first serve one time only basis. United Way of Greater Attleboro/Taunton funds this program.
- The Fuel Fund officially opens December 1st of each year. The fuel fund provides emergency financial assistance for fuel related costs to individuals families who are over income for the state and federal entitlement fuel assistance programs and the Salvation Army Neighbor Energy Program. Over the past few years the Task Force has made adjustments to provide limited assistance to those who have qualified for the previously mentioned programs. Determination is on a case-by-case basis. This program is made possible because of the

generosity of donations from area citizens and businesses.

Transportation Program -Due to a generous donation from the Bristol County Savings Bank Charitable Foundation, the **Taunton** Emergency Task Force inconjunction with Department of Human Services and GATRA is able provide a no-cost transportation program to low-moderate income individuals and families. This transportation program, based funding on

availability, provides public transportation passes for Neighborhood Fixed Route Buses (does not included Dial-A-Ride/cab fares) to eligible individuals, elders, and families. The Transportation Assistance Program hopes to alleviate the transportation costs of those who are eligible. A short application is required well income as verification, a positive ID and proof of City of Taunton residency. The number of passes provided will be based on current individual/family usage of public transportation. The income guidelines are based on 200% of the Federal Poverty Level.

Discussion Highlights:

Networking/Coalition Building

- One of the topics Attleboro adjustment counselors discussed at a recent meeting was that of school drug policies. Attendees expressed interest in the "Guiding Good Choices" parenting program. Attleboro schools have been active in several Substance Abuse Round Tables (SARTs).

School Drug Policies - Good examples of school drug policies are those of colleges and universities. These educate and present boundaries. Schools discipline often deal with problems and leave substance problems abuse to the community. Taunton's policy is drafted and includes use of a breathalyzer test. Other high schools have used these successfully, and may use Ph strips and a flash light devise that shows when alcohol is present on breath.

Youth Treatment - Group counseling is difficult to provide to teens due to insurance coverage and shortage of science based research at this time, to prove that it works well with youth. Juvenile court, judges,

probation, case management and parents need to be involved in mandated treatment and consequences. The local first offenders program, Community Drug Education, is a good example of a program that works. Attendees can maintain a clean record by attending the program, keeping them eligible for college loans, entering the military and not limiting employment possibilities. (Possession with intent is a felony).

After Prom Parties Concern -

It is essential that parents and youth be involved in planning and supporting successful after prom parties. The following are area best practices:

North Attleboro High School is using the YMCA for an all night party, and has use of the community room computer labs, and pool with supervision. lifeguard Parents are welcome and invited, and are encouraged to bring pizza and other food. Area businesses such Dominos Pizza and Dunkin Donuts have donated snacks at past school events. YMCAs work closely with schools and are insured.

- Old Rochester High School has provided all night use of the YMCA and facilities (rock climbing wall)
- ➤ Other all night events with a donated pancake breakfast and a raffle at 5:00 am for a donated used car or a year of car insurance
- Durfee High School is doing a bus trip to a ship in Boston. Attendance requires parents pick them up at 1:00am.
- A Hawaiian Luau or other theme-based party.

Grant Proposal – T.H.S. SADD Chapter has written a \$200 Governor's Safety grant for parent awareness and peer leadership. They are looking into distribution of a 15 minute CD for parents, a cable show with parents and youth, and use of a pre-prom awareness video.

Fact **Sheet:** From **PolicyImpact Communications** Awareness Campaign (Fitchburg Sentinel) targets adults combat problems of underage drinking. Parents feel pressure to provide alcohol to their children hosting parties at their homes, and young adults purchase alcohol for teenagers. Drinking is hitting middle schools now. The Fitchburg and Leominster group starting is with YRBSurvey and interviews with children. parents. business owners and school officials to grasp the amount of underage drinking and who is providing the alcohol. They are also doing a sticker shock campaign that states "Providing alcohol to underage people is a CRIME! Penalties may include: Arrest, A fine up to \$2,000 and/or imprisonment up to six months. Thank you for being part of the solution".

Working Together to Prevent Underage Drinking (Medford Transcript) – Two actions that reduce underage drinking include: 1. Parents keeping tabs and keeping lines of communication open and giving logical consequences. 2. Make it difficult for minors to access alcohol at home or through other adults.

<u>Trends: (Metrowest Daily News, "Treatment Pays Off"</u> – MA exceeds the national average in substance abuse. Almost 40,000 in the state need treatment but aren't receiving care.

- Alcohol abuse causes more than 200 traffic deaths each year
- Last year's cost was \$304.5 million
- > Drug overdose caused another 574 deaths in 2003
- Millions more are needed to process, feed and house the

1 in 5 prisoners convicted of a drug related crime, plus offenders who commit crimes under the influence or to support a habit.

New Choice in Drug Abuse (Boston Globe) – Prescription drugs, available in family medicine cabinets and online for \$2-5 per dose, are the new gateway drug.

CHNA Establishment –

The MA Department of Public Health created the Community Health Network Areas (CHNAs) in 1993, making smaller, more manageable geographic areas to improve health status indicators and inform the DPH on policies. MassChip health indicator data is arranged by CHNA. Initially, each CHNA chose one status indicator for focus. Attleboro

worked on Injury Prevention. Agencies that contract with DPH are required to participate in the This places these CHNA. agencies at the table, along with consumers and others who through working together, are able to better serve community. Determination of Need (DON) funding requires health organizations give 5% of capital expenditures for services such as MRI back to the

community through health services projects, either with input or managed by the CHNAs. DPH is a partner with the CHNA that is willing to work with us on what works best in our community.

GTHHSC - The GTHHSC has been in existence for over 20 years. Over the years since the establishment of the CHNA system, there has been a blending of existing groups, such as the GATHER Addictions Committee and the GTHHSC Substance Abuse Committee. At one time both Attleboro (#21) and Taunton (#24) had separate CHNAs to reflect their different geographic areas. GATHER has continued to outreach to the Attleboro area and has had some success at the committee level. Both communities have also worked well together through GATCH in addressing housing issues, the Substance Abuse Committee, and the Domestic Violence/Violence Prevention Committee. Attleboro Area Council addresses basic needs and is similar to Taunton's Emergency Task Force.

Technical Assistance – The DPH contract with Health Care of Southeastern Massachusetts

for the Southeast Center for Healthy Communities (SCHC) includes a limited amount of technical assistance for CHNAs. The primary focus of the SCHC in providing technical assistance to selected community-based Substance Abuse coalitions. CHNAs have access to trainings, assistance with the development of mission & vision statements, etc.

Geographic Area The GATHER area, as defined by the DPH includes Attleboro, Berkley, Dighton, Middleboro, Lakeville. Norton. North Attleboro, Mansfield, Raynham, Rehoboth, Seekonk and Taunton. GTHHSC includes the 8 cities and towns of greater Taunton (Berkley, Dighton, Lakeville, Middleboro, Raynham, Rehoboth, Seekonk and Taunton)

Discussion Highlights:

Introductions - Steve Turner, Chairman, welcomed members and local dignitaries. He thanked members for their support and commended SNI on its accomplishments and impact on the community.

Remarks - Mayor Nunes welcomed Cheryl Beauregard as the new SNI Chairperson. He stated that SNI has made a difference in our neighborhoods and schools. He discussed various policing scheduling changes, assignments of police officers to state and federal task forces, policing strategies and the effects of these changes. Guest Speaker: Linda Pacheco, Assistant Director of Public Programs, Bristol County Sheriff's Office: A PowerPoint presentation on the I Safe (Internet safety) program was provided. The presentation touched on topics such as computer sites; responsibility of parents to monitor their children while they are on the Internet; youth today are tech savvy; cyber-predators; youth needing know that there boundaries around responsible behavior, education and safety; that the Internet facilitates child pornography, piracy, plagiarism, identity fraud, theft and predators. Mrs. Pacheco stated that they are looking for people to be certified on presenting this program.
