Discussion Highlights: Project YELL

- Peer Leaders Peer leaders have been hired, and received orientation. April will meet with parents to sign permission forms. They will also participate in an all day training with MADD.
- School Survey Project YELL staff will meet with T.H.S. faculty to introduce Project YELL. The ADAS is scheduled for November.
- COMET Report The Project YELL quarterly report is about half finished. It is due November 10.
- Social Norms Conference April and Carol attended a social norms and law enforcement presentation.

\$10,000 Tobacco Grant Received – T.H.S. submitted both a \$2,000 school grant and \$10,000 community DPH mini grant. They are still waiting on the school grant, which is for second hand smoke and to stop smoking in school. Three more peer leaders and a coordinator can be hired with the \$10,000 grant, bringing the number of peer leaders to 8.

School Tobacco Cessation Program – There are currently no referrals, but students continue to hide before school to smoke. **Community Care Services SOAP** – The Structured Outpatient Addiction Program meets 5 days per week for 6 weeks, 2:00-4:30, after school. T.H.S. will give referrals.

November Ballot Question 1: Wine Sales in Food Stores -The advertisement that indicated MADD support for the bill has pulled. Access been and enforcement are issues for this bill because it increases the number of liquor establishments, making it harder to police. The law will also make it more difficult for youth who are under age 21 working in smaller, understaffed stores.

SARTXII – The committee is composing a letter to funders, stating what social norms is, how it will affect the community, expected impact, what we expect to get out of it, and what attendees can take away and use. Social Norms shows that most youth make healthy decisions, so the positive message has public interest built in. Negative messages are an easy sell to funders because people want to fix a problem and make it better. Social norms is prevention rather than treatment, and gives a "bigger bang for the buck" in that is has a strong influence on behavior with a relatively low cost. It sends the message that kids that make healthy choices are not strange. A letter to potential funders should motivate support for positive behaviors instead of having to deal with negative consequences in the future. Social norms messages are about life above the influence. We are seeking funding support to an established, funded, sciencebased program. The SARTXII is an opportunity to spread the word about the effectiveness of social norms and let communities know that there is much funding support available. A registration fee was also discussed and would require a different agency take the lead in collection and accounting.

They may take a survey the from internet, get statistics on underage drinking arrests and number of community liquor stores, and come up with a community action plan to present to the youth, along with getting the community to support the social norms campaign. Possible facilitators could include Deb, Carol, Tracy and Stephanie (SCHC).

Action Plan – The conference outcome will be a community action plan that every individual or group can take for community implementation.

Best Practices - Project YELL can be highlighted as a best practice, possible before the keynote speaker. It was originally written as a GATHER grant for 7 communities. Participants can take back the local perspective of Taunton's project to their communities. SARTXII Name – The committee explored various names for the next SART that would express "most of us". These include:

November Ballot Ouestion 1: Wine Sales in Food Stores allows local licensing authorities to issue licenses for food stores sell wine. This includes to grocery stores, supermarkets, shops. clubs. outlets. or warehouse-type sellers, that sell food to consumers to be eaten elsewhere. The licensing authorities in any city or town of up to 5000 residents could issue up to 5 licenses for food stores to sell wine. In cities or towns of over 5000 residents. one additional license could be issued for each additional 5000 residents (or fraction of 5000). Such licenses would not be counted when applying the laws that limit the number of other kinds of alcoholic beverage licenses that may be issued or held. Any applicant for a license would have to be approved by the state Alcoholic Beverages Commission. Control Local authorities could set fees for issuing and renewing such licenses. Taunton has 24 licenses with 16 proposed. This law will increase the supply of alcohol in the community. Youth argue that MADD is pro question 1 and the

data supplied by the opposition is not true. (Note: According to the Boston Globe. MADD Massachusetts it savs is remaining neutral the on question because it does not involve itself in licensing issues.) Deb has information from the Youth Summit where students debated for and against Availability the bill. and enforcement are issues as this could add another 17 bill licensees.

Trends – A new drink called MD 20/20 or Mad Dog has gained popularity with teens. (Additional information from Wikipedia: MD 20/20 or Mad Dog is a fortified wine that comes in a variety of flavors that appeal to youth. Alcohol content varies between 13.5-18%. The combination with high fructose adds a sugar rush to the intoxication. It is rumored that getting drunk on MD 20/20 often causes intense hangovers the following day, likely because many of the drinkers are inexperienced, underage drinkers. It is popular with teens because it is inexpensive and has a high alcohol content.




