### What Ever Happened to GATHER?

In 1992, the Massachusetts Department of Public Health established the Community Health Network Area (CHNA) effort. A CHNA is a local coalition of public, non-profit, and private sectors working together to build healthier communities in Massachusetts community-based through prevention planning and health promotion. Today this initiative involves all 351 towns and cities throughout the 27 Community Health Networks.

The Greater Attleboro/Taunton Health & Education Response (GATHER) was established in 1996 as a result reorganization ofthe CHNA's, with a merger Greater **Taunton** between CHNA#24 and Attleboro's CHNA (CASH).

The newly formed GATHER selected unintentional injury prevention. addictions domestic violence as topics of focus. The Injury Prevention Committee worked organizing the highly successful and well attended annual Kids Safety Fair at the Emerald Square Mall, as well initiatives such as carbon monoxide detector give-aways to low-income families. The Addictions Committee shared membership with that of the

Greater Taunton Health & Human Services Coalition's Substance Abuse Committee, so both committees merged into the GTHHSC/GATHER Substance Abuse Committee. This summer, the Domestic Violence Committee was renamed "Southeastern Massachusetts Voices Against Violence". Monthly GATHER networking meetings were discontinued to reduce the number of meetings GATHER members needed to attend, and **GATHER** membership was fulfilled where the work happened - in the committees.

#### Reorganizing CHNA#24

Over the past few months. committed individuals from the 12 GATHER communities met to restructure the CHNA. They unanimously agreed that the new CHNA structure best represented by a wheel with hub (The CHNA) and spokes (Area committees and coalitions).

A "spoke" is a grouping of individuals, agencies and organizations for a purpose. Two representatives of each "spoke" will be selected by his/her committee to attend quarterly networking meetings.

Under this new structure, DPH CHNA attendance requirements may be filled by agency representation on any "spoke". All area coalitions invited committees are to become "spokes", and may include Attleboro Community Council, Greater Taunton Health & Human Services Coalition. Substance Abuse Committee, Southeastern Voices MA Violence. **Taunton** Against Emergency Task Force, Safe Neighborhood Initiative, Greater Attleboro Taunton Coalition on Homelessness, Child and Family Focus Committee, Community Wellness, Health and Activate Attleboro. The CHNA is open to new groups as well. standing agencies, including hospitals, may become part of the CHNA by joining an established committee/coalition.

stronger among women than

'Good' Young Drinkers Bound for Alcohol Problems - Young people who have a low response alcohol often become alcoholics later in life. researchers say. Those who could drink their peers under the table as youths later became alcoholics because they had to drink more to get intoxicated -which is why young people drink. (Jointogether)

Surgeon General Report **Details Serious Secondhand** Smoke Health Hazards Secondhand smoke. orenvironmental tobacco smoke, is a combination of the smoke given off by the tobacco product and exhaled smoke. Homes and workplaces are the predominant locations for exposure.

- There is no risk-free level of exposure to 2<sup>nd</sup> hand smoke.
- ➤ 2nd hand smoke causes premature death and disease in children and in adults who do not smoke.
- Children exposed to secondhand smoke are at an increased risk for sudden infant death syndrome (SIDS), acute respiratory infections, ear problems, and more severe asthma.
- Smoking by parents causes respiratory illnesses and slows lung growth.
- Exposure of adults to secondhand smoke has immediate adverse effects on the cardiovascular system. It

- increases the risk of coronary heart disease by 25% to 30%.
- **Exposure** to secondhand smoke is linked to an increased risk for lung cancer among nonsmokers. For example, nonsmokers living with a smoker have a 20% to 30% increase in the risk of lung cancer from secondhand smoke exposure. Eliminating indoor smoking is the only way to fully protect nonsmokers from secondhand smoke. See report www.cesar.umd.edu/cesar/cesarf ax/vol15/15-34.pdf. (Jointogether)

U.S. Drinkers Report Lower Alcohol Tolerance - There has been "a clear and statistically significant reduction" tied to changing American attitudes about intoxication. In the 1950s, "it wasn't until you couldn't physically control yourself that vou were considered drunk." The shift in attitudes relates to the adoption of tougher drunkdriving laws and more educational attainment. Michael Hilton, Associate Director Division of Epidemiology & Prevention Research at the National Institute for Alcohol Abuse and Alcoholism noted that, "If you know attitudinal changes are linked to actual consumption changes, then you might conceivably be able to target consumption better. It could potentially give you a lever for knowledge useful in prevention." The research was published in the October 2006 iournal issue of the Addiction. (Jointogether)

- ➤ Substance Abuse Round Table XII This year's SART will focus on social norms, a proven process for reducing drinking by correcting perceptions. The

first meeting was held last week during which the group began to discuss bringing in a well known speaker. The next meeting will be held **10/11/06**, 3:00, at Project Empower Conference Room at CCBC. (Enter the old Taunton Mall using the door to the registry, turn right. The CCBC office is on the left.)

**Presentation: Project YELL** (Youth **Endorsing** Legal Lifestyles): April Cabrera, Youth Coordinator - After a disruption in funding, Project YELL was reinvigorated this summer with the hiring of two staff members: Carol new Annarino, Project Director, and April Cabrera, Youth Coordinator. Both, along with Lorraine and Deb, attended a social norms training in July. Each representative of Project YELL attended one of the four tracks relative to the project. Peer leaders will soon be hired. Social Norms changes perceptions by showing that most high school youth are making healthy decisions, which reinforces the good behavior of the majority. SN began at the college level and was shown to

correct the perception that students drink more than they actually do by using surveys to gather accurate use data. Once collected, short messages are fashioned into posters, billboards, etc. Peer pressure encourages adherence to the norm, which usually shows that students do not drink nearly as much as students thought. Deb. Carol and April will meet with the high school principal to discuss social norms, youth surveys and saturation of Social Norms messages at the school. Once hired, peer leaders will participate in an October 28 **MADD** Youth in Action Training. Other plans include offering the parent program "Guiding Good Choices" to protective increase factors. There is no program in Taunton yet but it has been presented. The schedule is very lengthy and may not be realistic for a school based program. If this is the SOAP program it is an after-school-based program offered by Community CARES with grant and insurance money and it is being offered to Taunton schools as well

**Special Note:** Deb's mother passed way this summer. Flowers were sent on behalf of the Task Force.

**Fund Raisers** - \$1335.64 was the total amount raised from all fundraising events (raffle and mailing). A big thank you to all members that sold raffles. especially Jan Bruce. Guidelines for emergency funds need to be amended. Funds will only cover emergency situations not covered any other by funding/resources. TETF was denied funding from Hannaford's' Charitable organization but has been collecting money for TETF through the kiosk since July.

Homeless: Over the summer, Heart of Taunton held 2 meetings to address the issue of homeless individuals loitering downtown causing disruption for the businesses in the area. A sub-committees will address this. Homeless advocates stated the homeless are in hiding but that camps continue to grow. People have no places to go with few resources to help.




