"Dress to Impress" For Job Interviews

(From SEMA-VAV)



First impressions can make or break

a job interview. Dress to Impress will provide off-therack quality business attire to qualified residents within the Greater Taunton and Attleboro communities who are entering or re-entering the workforce. This public service will be at no cost referred the client. coordinated by volunteers and will fill a much-needed gap in resources. It is located at the First Parish Church of Taunton at Church Green.

Background:

While this attire for hire project has been discussed for several years within both the GATHER Domestic Violence/Violence Prevention Committee and South Eastern Massachusetts - Voices Against Violence (now consolidated into one coalition, SEMA-VAV), the need for this service is not restricted to domestic violence or crime victims, but includes low to moderate-income residents who are entering or returning to the workforce. These women and men will be referred by

agencies and organizations, such as the Taunton and Attleboro Career Centers, Taunton School to Careers, MA School of Information Technology, unemployment, Department of Transitional Assistance, MA Rehab Commission, Associates for Human Services, veterans agents, shelters, and GED programs, to name a few.

The goal is to offer each person at least one interview-ready outfit at no cost. SEMA-VAV will continue to seek grants & community donations to offset operating expenses.

Dress to Impress was launched on 6/1406, during a press conference at the First Parish Church of Taunton. After press coverage, 65 calls and emails were received from the Greater Taunton and Attleboro areas, including Mansfield and the Bridgewaters, and volunteers came forward, as well one Girl Scout Troop. Business attire will be collected year-round and will be available as much as possible during this time frame.

- Donate Clothing Off-therack quality business attire in all sizes for women and men, including accessories such as shoes, ties, briefcases, raincoats, scarves, pocket books, umbrellas, etc.
- Volunteer to assist those referred to *Dress to Impress* select interview clothes. Access is by appointment only. Coordinator Tracey Medeiros will schedule volunteers for only 2-3 hours a month.



Did You Know That...?



Churches and nonprofit groups risk losing their taxexempt status if they engage in political campaigning, the IRS warns. The <u>Foundation Center</u> reported July 19 that the IRS recently sent notices to 15,000 nonprofits, churches, and tax preparers outlining its Political Activity Compliance Initiative. The agency warns that it will immediately investigate claims of improper campaigning rather than waiting for a tax return to be filed or a fiscal year to end; a three-person panel will review complaints to determine if further action is needed. Since 2004, more than 200 groups have been investigated by the IRS for political activity; 62 were found in violation of tax laws, 59 got warning letters, and

three lost their tax-exempt status. (JoinTogether)

Substance Abuse

'Social Innovative Norms' Campaign - The Broward County Commission Substance Abuse has partnered with Broward County Schools to target students with a "social norms" campaign, the Sun-Sentinel reported on August 7. The campaign collected data on the drinking habits of teens and discovered that four out of five kids claim that they do not usually drink when hanging out with friends, but that they see their friends drinking. Based on

this information, **Ambit** Marketing, the company that ran the campaign, titled it "Four out of Five." In its first phase. Ambit created t-shirts, posters, bracelets, pencils, Post-Its, mugs, and automated calls to students in multiple languages. Now in its second year, the campaign hopes to gain strength with billboards, signs, newspaper ads and the participation of local businesses. The approach of this campaign is an innovative one. "Traditional campaigns were created to scare them," said Kathy Koch, president of Ambit Marketing. "Social norms campaigns are designed to tell them the reality of what with their friends are doing, and work with the kids to believe and adopt this healthy through behavior the years." Parents **Dramatically** Underestimate Alcohol and Illicit Drug Use by Youth, according to data from the most recent national Pride surveys of parents and students. One-fifth (21%) of students in 6th grade reported that they had drunk alcohol at least once in the past year. Yet only 5% of parents said that their 6th grade child has tried or is using alcohol. While the gap between students' selfparents' reported use and perceptions of their own children's use narrows with age, parents continue to significantly underestimate alcohol use by youth. More than two-thirds of 12th graders reported past year alcohol use, while only 41% of parents thought that their 12th grade child had used alcohol. Similar results were found for illicit drug use. For example, 36% of 12th graders reported using illicit drugs at

least once in the past year, while 15% of parents reported that their 12th grade child used drugs. For details see www.cesar.umd.edu/cesar/cesarfax/vol15/1531.pdf. (JoinTogether)

This study estimated the magnitude and costs of problems resulting from underage drinking by traffic crashes. category: violence, property crime, suicide, burns, drownings, fetal alcohol syndrome, high-risk sex, poisonings, psychoses, dependency treatment. compared costs with associated alcohol sales. With Courts' Blessing and Federal Funds, School Drug **Testing Grows** - The Bush administration last year gave 373 public secondary schools funding for random student drug testing, up from 79 two years ago, USA Today reported July 12. An estimated 225 other schools are conducting testing using private funding, the White House estimates. In fiscal year 2007. President Bush is asking Congress for \$15 million for grants supporting student drug testing. а proposed 45% increase. Some schools have expanded testing to include random testing of students who drive to school and those attending dances, proms, or class parties. (JoinTogether)

Mass. Launches New Northshore Recovery High School for students who have had problems with drugs and the Boston Globe alcohol. reported on August 13. In order to be admitted to the school, students must be sober, agree to random drug testing, pledge to stay sober, and attend two 12step meetings a week. program has 10 enrollees and intends on having 40 by the end of the school year. In addition to math, English, history, science classes, students will have one hour of group therapy a day, as well as electives in art, drama, music, and video. After a 9 a.m. to 3 p.m. day, students with no after-school job or 12step meeting to attend will remain at school to homework or take extra classes. The school's director Michelle Lipinski states "I want these

students to stay safe, and I want them to get high-quality academics, and I want them to go to college." (JoinTogether)

On-Line Screening Test -AlcoholScreening.org is easy-touse and scientifically validated. Users answer a few quick questions, instantly finding out if their drinking patterns are likely to be risky or harmful. Why don't vou give it a try? Join Together developed and supports this free tool for addiction and health professionals. those curious about their own drinking, clients, patients, colleagues, peers, friends and others. More than 400,000 people have already completed the screening. (JoinTogether)

Early Alcohol Users are 5X More Likely to Be Alcohol Dependent in their Lifetimes according to an analysis of data from the National Epidemiologic Survey on Alcohol and Related Conditions (NESARC). Nearly one-half (47%) of persons who began drinking before age 14 were alcohol dependent at some point in their lifetime, and 13% were dependent in the past year, compared to 9% and 2%, respectively, of those who began drinking after age 20. Early drinking was also related to higher rates of dependence within 10 years of onset of drinking and dependence before age 25. The Health Consequences of Involuntary Exposure to Tobacco Smoke: A Report of the Surgeon General concludes that there is no risk-free level of exposure to secondhand smoke.

Nonsmokers exposed secondhand smoke at home or work increase their risk of developing heart disease by 25 to 30% and lung cancer by 20 to 30%. Nearly half of all nonsmoking Americans are still regularly exposed to secondhand smoke in homes, worksites, schools, and public places. The report finds that even brief secondhand smoke exposure can cause immediate harm. The report says the only way to protect nonsmokers from the chemicals dangerous in secondhand smoke eliminate smoking indoors. Discussion Highlights:

Telephone Conferencing – Lorraine will be available to attend meetings or other contact through email at mcaprosa@hotmail.com, or Skype mrosanet. A backup minutes taker will be assigned at the beginning of each meeting.

Outpatient Addiction Program

- Community Care Services and Attleboro Public Schools are continuing an after school team program 5 days per week, for boys and girls. It includes psycho education counseling and group, life skills for people with addictions, and is open to teens 13-17. Enrollment in Attleboro schools is not a requirement. Transportation can be available by community caravans for low income Attleboro residents, or through a PT1 (non-emergency medical or counseling, paid Medicaid through through GATRA with a physician's signature. The after school day treatment begins in mid September.

Community Smoking Intervention Planning Project

 Community Care Services is submitting a \$15,000 grant proposal to the DPH for a Community Smoking Intervention Planning Project for Taunton. It will fund an 18 community planning process. At the end of the process, a written plan will be ready for implementation of an evidence-based intervention to reduce smoking prevalence in the community by changing community norms in order to influence behaviors, ultimately, reduce tobacco use prevalence in the state. Their plan includes strong integration with the SAC. This grant will provide an exciting opportunity begin process the reinstating preventative services to reduce the incidence of

smoking in the City of Taunton, which as MassChip statistics show, is greatly needed.

Unanimous Approval – The SAC voted unanimously to make the tobacco control grant a part of the monthly agenda. Under the new CHNA structure, the SAC is not required to include all 12 CHNA communities in this initiative.

Medicaid and Tobacco – On July 1, 2006, community health centers may bill Medicaid for tobacco services. MassHealth recipients may get nicotine patches if they are prescribed.

CHNA Planning Update – The former GATHER coalition is being reorganized. The new organizational chart resembles a wheel with spokes (individual committees from the 12 communities that make Greater Attleboro and Taunton) connecting to a hub (the CHNA Committee). Steering spokes may be added when a new committee meets the criteria. CHNA meetings will be held quarterly and be attended by 2 representatives from each spoke. An annual meeting will be open to the complete membership of all committees or "spokes", the first of which will be held in October of 2006, at which time a new name will be chosen. The function of the steering committee is to provide feedback, data sharing and needs assessment information. The first meeting will focus on the roles of the steering committee. After quarterly meetings, representatives will take back information to their respective committees. emphasis on this new structure is to work on what already exists and look at gaps. Local press will be invited to cover the annual meeting. See minutes, pages 5-6.

Project YELL (Youth Endorsing Legal Lifestyles, a Drug Free Communities Grant)

- **→ Program Director** Carol Annarino (508-977-8165) is the new Program Director of this youth alcohol reduction program that uses a social norms approach through surveys, focus groups, promotion and marketing. She will be meeting with MADD, Taunton schools, and other key individuals. She is setting up her office, going through the files, attended a social norms conference, and is getting organized for the project. background is education, and she is on faculty of the Community College of Rhode Island.
- → Peer Leadership April Cabrera, former peer leader will be working with peer leadership. She is currently researching keeping youth engaged, working on the role of peer leaders, and revising the job description and job posting. The job description will be shared with the Committee, Taunton schools and Boys and Girls club members.
- Surveys to be administered to high school students must include the following four core measures: Past 30-Day use, average age of onset. perception of risk, perception of parental disapproval. Last years, Montana was hired as survey specialists. survey Their remains their property.

- → Letters to Senators Thank you letters will be sent to Senators Biden and Grassley for their assistance in spearheading efforts to refund Project YELL. These will be signed by Lorraine, SAC and Carol, Project YELL.
- **Involvement** Senate Senate appropriators want to keep the Office of National Drug Control Policy out of Communities Drug Free decisions. The Senate committee's bill includes ONDCP and other White House agencies when it says that no (DFC) grantee shall be suspended or terminated unless they are afforded a fair, timely, independent appeal. This is a result of the 2006 defunding of coalition programs such as Project YELL, 63 of which had funding reinstated.

XII _ An environmental strategies approach to social norms was suggested as a topic. environmental portion The requires going beyond providers students. and include parents, media, business and community segments working together to get the word out about the true social norms, rather than skewed perceptions of teen alcohol use. When surveys reveal that students' actual use of alcohol is below individual perceptions of alcohol use, peer pressure works as a positive force in encouraging less risky behavior. The SARTXII can get the word out about youth drinking norms, and show how a social norms project is done. This is a new approach to youth alcohol issues. Project YELL has reserved \$2,000

GTHHSC/GATHER Planning Committee Update – The kickoff meeting and GTHHSC annual meeting will combine for a single event in October. Each area coalition or committee is asked to bring one sheet of information about their committee and membership, as well as a visual, tri-fold poster to display. The new organization chart shows coalitions and committees as spokes of a wheel.

YMCA of North Attleboro is a youth serving organization with teens that may be interested in connecting with Project YELL compliance checks, networking, and sharing data and information. The YMCA allows groups to come and see the programs offered.

Orientation Packet – A Committee informational packet needs to be updated and shared with members to help them become part of the GTHHSC and CHNA#24. Suggested items to include are a membership roster, newsletter and organizational chart.

Project YELL (Youth Endorsing Legal Lifestyles):
