Please read these Terms of Use ("Terms", "Terms of Use") carefully before using the <http://hon-albert-gallatin.com>, <http://geocities.ws/hon-albert-gallatin>, <http://albert-gallatin-project.com>, or <http://geocities.ws/albert-gallatin-project> websites (the "Services", the "Sites") operated by Ronald Duquette who portrays Albert Gallatin, the Fourth Secretary of the United States Treasury ("Mr. Duquette", "Mr. Gallatin", "us", "we", or "our").

- These Terms of Use apply to all Sites listed above.
- Your access to and use of the Services/Sites is conditioned on your acceptance of and compliance with these Terms. These Terms apply to all visitors, users and others who access or use the Services/Sites.
- While we do not currently require you to accept these Terms, if you disagree with any part of the terms, then you should not continue your access to the Services/Sites.
- Currently, we do not register visitors for accounts. At no time are you required to register to explore the Site.
- Also, your contact information is NOT shared with parties who are not Mr. Duquette's staff, colleagues, or otherwise specifically listed in one of the Sites or specific to a program under the Albert Gallatin Project.
- We do have security protocols in place on the Sites that automatically report malicious activity (including but not limited to inserting redirection scripts or malware to the Sites) or the harassment of Mr. Duquette, his staff, colleagues or others listed within the Site) to law enforcement for investigation and prosecution.
- Penalties resulting from prosecution are determined by a court of competent jurisdiction closest to your location.

Termination

- We may terminate or suspend access to our Services/Sites immediately, without prior notice or liability, for any reason whatsoever, including without limitation if you breach the Terms.
- All provisions of the Terms which by their nature should survive termination shall survive termination, including, without limitation, ownership provisions, warranty disclaimers, data privacy, indemnity and limitations of liability.

- Mr. Duquette has no control over, and assumes no responsibility for, the content, privacy policies, or practices of any third-party web sites or services. You further acknowledge and agree that the Mr. Duquette shall not be responsible or liable, directly or indirectly, for any damage or loss caused or alleged to be caused by or in connection with use of or reliance on any such content, goods or services available on or through any such web sites or services.

Governing Law

- These Terms shall be governed and construed in accordance with the laws of the United States of America without regard to its conflict of law provisions.
- Our failure to enforce any right or provision of these Terms will not be considered a waiver of those rights.
- If any provision of these Terms is held to be invalid or unenforceable by a court, the remaining provisions of these Terms will remain in effect.
- These Terms constitute the entire agreement between us regarding our Service and supersedes/replaces any prior agreements we might

have between us regarding the Service.

- Be aware that European Data Privacy laws that enter into force on May 25, 2018 are incorporated by reference here. Note, that we do not collect information regarding a visitor's country of origin unless the visitor has requested information be provided via postal services in the United States or their home country.

Reason for the Changes Now Being Made

- The Albert Gallatin Project is an educational program regarding the history made during the lifetime of Albert Gallatin and his colleagues. It may also offer programs related to events after Mr. Gallatin's death.

- To efficiently organize programs in the Gallatin Project framework, it is necessary to involve Third Parties for sponsorship and to facilitate hosting, publicity and certain related financial transactions. Therefore, it becomes necessary to share certain personally identifiable information with these parties for the orderly organization and hosting of a given program.
- Databases will be maintained so that you may be contacted with information updates you have requested. The information may be supplied to you by either Albert Gallatin Project staff or representatives of the hosts or sponsors, depending on who is handling dissemination of the information.
- Those registering to attend a program, and the presenters, will be asked to provide certain financial information to the program registrar, usually the hosting venue, to process the necessary financial transactions. The institution's security protocols regarding these transactions will prevail regarding the information required.
- Should a communication from a Third Party claiming to represent any of our projects or sites give you concern, please contact us immediately.
- These changes are intended to account for evolving issues in data privacy to the extent possible.
