- Besides pharmacologic management, infrared light therapy may be used for peripheral neuropathy.
- Pregabalin/Lyrica is used in diabetic peripheral neuropathic pain (DPNP) and post-herpetic neuralgia. (PHN). Its side effect profile is similar to Gabapentin/Neurontin.
- Dufloxetine/Cymbalta may have side effect of nausea that decreases over time.

Overview: Seasonal Influenza

Are you one of the 40% of U.S. healthcare workers (HCW) that routinely receives a flu shot? Or are you part of the other 60%? Did you know that the CDC has recommended that HCWs receive this immunization since 1981? Professional organizations, including the Association for Professionals in Infection Control and Epidemiology, the Society of Hospital Epidemiologists of America, the Infectious Diseases Society of America, the Expert Panel on Strengthening Adult Immunization, have endorsed a policy requiring influenza immunization of HCWs who have direct patient contact. Many health systems now see this as a patient safety and quality-of-care issue. It is not too late to get your flu shot now!

Regular Consumption of Cola May Be Linked with Hypertension in Women Pearls for Practice

- * Caffeine intake may raise blood pressure acutely through the release of stress hormones, but it has not been demonstrated conclusively to increase the risk for hypertension.
- * While total caffeine consumption, coffee intake, or tea intake were not associated with a significant increased risk for hypertension among women in the current study, higher consumption of cola beverages raised this risk.

Pearls for Practice

- * Cola may reduce BMD through higher intake of caffeine, high fructose com syrup, phosphoric acid, or some combination of these effects.
- * The current study demonstrates that higher degrees of cola consumption may be associated with reduced hip BMD among women. However, cola consumption did not affect BMD among men, and it failed to significantly reduce BMD in the lumbar spine in either sex.
