

AKO Email Account

As you may have noticed, we're trying to get email addresses from everyone in the company. One option is to get a free AKO email account; you can send larger attachments than some free accounts and you can access them from any computer. These accounts also should not get blocked and will be the most reliable way to email your soldier. Go to www.us.army.mil and click on New User. Choose the Guest Account option and fill out the form that follows. You will need to know your sponsor's AKO account username. Once you have completed the application, your sponsor will need to authorize your account by logging in and clicking on Sponsor Management.

DEPLOYMENT INFORMATION FOR B (0. / 115TH FSB

Amendments To The Soldiers And Sailors Civil Relief Act Of 1940



Overview:

On December 22, 2003, the President signed a new law that completely revamps the Soldiers and Sailors Civil Relief Act of 1940, (50 U.S.C. App. 501 et seq.) now known as the "Service Members Civil Relief Act" ("SCRA"). The new law modifies and liberalizes the conditions for termination of residential and personal property leases before certain deployments or PCS. The SCRA also provides several additional protections not detailed below.

The SCRA Applies To:

A ctive Duty Service members, members of the National Guard called to active service for 30 or more consecutive days, and Reservists ordered to active duty.

Termination Of Residential Leases:

Service members may terminate a residential lease after receiving orders to deploy with a military unit for no less than 90 days, or after receiving PCS orders. Soldiers must provide written notice of intent to terminate. Termination is effective 30 days after the first date on which the next rental payment is due. If interested, the soldier may request a copy of these letters from the company chain of command.

Stay Of Proceedings:

The SCRA prevents a service member from being sued in civil court if the service member's military duty materially affects their ability to defend themselves. This protection does not apply to criminal cases. Further, if civil court chooses to proceed, the court must appoint an attorney to protect the service member's interests.

Termination Of Motor Vehicle Leases:

A service member may also terminate an automobile lease (or their dependent's) if he/she (1) receives a military service call for not less than 180 days; (2) receives PCS orders

than 180 days; (2) receives PCS orders OCONUS; or (3) receives orders to deploy with a military unit for not less

than 180 days. Dependents are protected under this section if they can show that their ability to pay is materially affected by reason of the servicemember/sponsor's military service.

Waiver Of Rights Under The SCRA:

Service members may waive in writing any of their rights and the protections contained in the act. If you have are unsure if you have waived your rights under the new SCRA, contact the Legal Assistance Office before attempting to terminate the lease.



- Combat Zone Tax Exclusion (CZTE)- Areas designated as combat zones are exempt from paying Federal Income Tax. Officers are limited to \$5,957.70 (SMA's pay of \$5,732.70 + \$225 for HFP) for tax exclusion. These CZTE figures are estimates including only Base Pay and HFP.
- Per Diem-\$3.50 per day. All per diem is paid upon travel settlement.
 BAS-Married soldiers receive BAS automatically.
- Hos tile Fire Pay (HFP)- Areas designated as hos tile fire pay areas are entitled to \$225/month in 2003.
- 5. Family Separation Allowance (FSA-II)- Payable to soldiers with dependents, starting after 30 days of separation Rate is \$250/mth (\$8.33/day) in 2003.
- 6. Hardship Duty Pay (HDP)- Rates are based on location and the designation of that area. Rates vary based on location. Rate is currently \$100 for Iraq. May be different in Kuwait for the time that we are there.

Mail To Your Soldier



omplete addresses will not be released until we have arrived at our permanent location in Iraq. This delay is intended to ensure that mail will reach us if we are diverted to a new location once we arrive in Iraq.

Rank, Last Name, First Name B Company, 115th FSB, 1st CAV DIV APO AE 093XX (The XX will be provided once we arrive.)

DO NOT add camp location, city or country to the address format-doing so could unintentionally reroute mail to the international mail bin in New York (vice the APO mail bin) and delay getting mail to the soldier in theater.

The following items may not be mailed to soldiers in Iraq: Alcohol, Pornography, Fireworks, Drugs, Weapons, and Aerosol Cans. When packaging mail, consider that it will be handled by a variety of people who may not care about the condition of your package. The spouses of 4th ID have recommended a "drop and kick" test. If the packaging survives you dropping it and then kicking it across the room, it should make it.

There are size limits for packages being sent to Iraq. The postal service recommends shoe box size packages as they are easier to handle and are

therefore more likely to arrive on time. The current transit time is 15-20 days.

Soldiers will be able to send free mail back from Iraq to include personal letters and sound recorded correspondence. Larger packages will require processing through a mail office, which will be limited.

"Any Service Member" mail is no longer authorized. If you would like to send a care package to the entire platoon or company, it may be addressed to "Commander" and it will be distributed to the desired unit.
