

**INDAVA 2009 \*\*\*\* EXPECTATIONS FOR PARTICIPATION \*\*\*\***

1. This document outlines expected behaviour during Indava 2009. A participant is defined as “any person, adult or child, who is involved in Indava 2009 in any capacity.”
2. Participants and/or their parent(s)/guardian(s) must review this form thoroughly before signing it.
3. All participants agree to follow the procedures of Scouts Canada as outlined in the current Scouts Canada By-laws, Policies & Procedures, which can be found at [www.scouts.ca](http://www.scouts.ca)
4. Scouts Canada will not tolerate acts of discrimination and/or harassment on the basis of race, national or ethnic origin, colour, age, religion, sexual orientation, marital status, family status, disability or conviction for an offence for which a pardon has been granted.
5. The emotional, physical, verbal or sexual abuse of any participant will not be tolerated.
6. Adult participants may only smoke in designated smoking areas, not in sight of youth.
7. No alcohol or illegal substances may be brought to or consumed at any Indava 2009 activities.
8. Any material that may be deemed a “weapon” will be confiscated and the individual may be sent home.
9. In the event of suspected “banned materials, an Indava 2009 committee member may perform a search of belonging for the purpose of confiscation of such banned materials. With the individual and another adult present.
10. The privacy of the individual is to be maintained at all times. No person shall disregard another’s privacy as it regards to personal belongings, accommodation or hygiene facilities.
11. No one will leave the camp site or activity site without informing the sub camp chief or a member of the committee.
12. Actions and behaviours that jeopardize the safety of the participant or the group will not be tolerated.
13. Upon arrival at camp, all youth will be subjected to examination for head lice. Should any youth be found to have it they will be asked to leave camp for treatment & when cleared they will be allowed back to camp. No refund on fees.
14. Any violation of this document will be cause for disciplinary measures and will result in discipline that may include the participant being sent home.

I further understand that any violation of these expectations will be cause for disciplinary measures and if such results in my being sent home it will be at my own or my parent’s expense and no portion of fees will be refunded.**
