

# Music Industry and Recording Association

## Constitution

### Article I

#### Name and Purposes

**Section One:** The Name of this organization shall be: Music Industry and Recording Association (MIRA)

**Section Two:** The propose of MIRA is to fulfill student's growing interest in various areas in the music industry.

**Section Three:** The purpose of this organization will be to serve as a creative outlet for music enthusiasts and students interested in the music industry. Music promotion and recording projects will be discussed and organized throughout the school year.

**Section Four:** The use of the name Music Industry and Recording Association (MIRA) shall be used only for matters pertaining to business conducted by MIRA.

### Article II

#### Membership

**Section One:** Any Current Central Missouri State University Student or faculty member is eligible to become a member.

**Section Two:** All members must complete a membership application prior to membership.

### Article III

#### Officers

**Section One:** Officers of MIRA will be as follows: President, Vice-President, Treasurer, and Secretary.

**Section Two:** Two Chairpersons and an advisor will be the only leadership roles until elections are held.

### Article IV

#### Elections

**Section One:** Elections for any position will be held at the beginning of a new semester. (Note: elections will not be until after the first full running year)

**Section Two:** Any individual must be nominated before elected into a position

**Section Three:** current members may elect any individual to a position upon and acceptance of a nomination, and a majority of the vote.

### Article V

#### Use of Student information

**Section One:** Any use of student information included in the MIRA application will be used only for matters pertaining to MIRA business.

**Section Two:** the officers of MIRA as outlined in Article III can only access personal Information

### Article VI

#### Meetings

**Section One:** Meetings will be held on a weekly basis. Each meeting will occur at a time agreed upon my the majority of the members

**Section Two:** Meetings will be held for matters regarding MIRA.

### Article VII

#### Committees

## **Constitution**

**Section One:** Committees will be formed as needed and organized by the Vice President.

**Section Two:** Committees will have the responsibility of working for the benefit of the organization by performing tasks approved by the Vice President.

**Section Three:** The Executive Board will consist of the two chairpersons (President and Vice President), faculty advisor, and any other officers of any committee in MIRA.

## **Article VIII**

### **Amendments**

**Section One:** This constitution can be ratified and amended by request of qualified members as outlined in Article II of the MIRA constitution.

**Section Two:** Ratifications must be motioned during a meeting and be seconded by another qualified member. Amendments shall not be valid until a copy is placed on file in the office of Campus Activities.

**Section Three:** Amendments cannot be voted on until one meeting after following motion.

## **Article IX**

### **Discipline**

**Section One:** Any individual caught violating anything in this constitution will be reevaluated for membership by the expectative committee.
