

The Embassy of the Republic of Indonesia in Singapore would like to state that with effect from 01st August 2005, As you are aware only nationals from 11 countries are exempted from acquiring visas to enter Indonesia and further 36 other countries can obtain their visas at the stated ports of entry upon arrival in Indonesia. All other nationalities not mentioned above must apply for a visa prior to entering Indonesia.

Applicants must hold a valid passport which validity must be of minimum 6 months beyond the date of entry in the country. The categories for visas are for tourists, social and cultural visits, business and transit. The single entry visa costs USD 10.00 for a 7-day stay or USD 25.00 for a 30-day stay, applicants must also produce a return or onward ticket and there is no possibility to extend this visa.

THE VISA APPLICATION MUST BE SUBMITTED WITH 1 PHOTOGRAPH AND FEES OF S\$70.00. VISITORS SHOULD BE IN POSSESSION OF A VALID PASSPORT WITH MINIMUM OF 6 MONTHS VALIDITY AND A RETURN OR AN ONWARDS JOURNEY TICKET AT THE TIME OF ARRIVAL. FOR A SINGLE ENTRY BUSINESS VISA A LETTER FROM THE SPONSOR'S COMPANY IN INDONESIA IS REQUIRED IN ORDER TO SUBMIT APPLICATION. THE SOCIAL AND CULTURAL VISIT VISA IS FOR LONGER STAYS IN INDONESIA AND REQUIRES SPONSORSHIP FROM AN INDONESIAN NATIONAL. THIS VISA CAN BE RENEWED FOR A PERIOD OF MAXIMUM 6 MONTHS AND A FEE IS LEVIED EACH TIME IT IS RENEWED ONCE IN INDONESIA..
