AWARDS:

National Cash Prizes to 3 Top Winners:

- 1st Place: \$250.00
- 2nd Place: \$100.00
- 3rd Place: \$50.00

Each State Winner, including the national winners, receives an appropriate book about honey bees, beekeeping, or honey.

Texas Cash Prizes to 3 Top Winners

- 1st Place: \$100.00
- 2nd Place: \$75.00
- 3rd Place: \$50.00

TOPIC:

For the 2008 essay contest, the essay topic is: "The Results of Honey Bee Pollination in My Community"

The results of honey bee pollination are many and varied. Essayists are encouraged to become familiar with these pollination activities and, then, survey their communities to see what examples they can find. Some of these will be obvious, i.e., apples on sale at the supermarket. Others may be less obvious, i.e., milk from cows that are fed alfalfa hay with honey bees used to pollinate the original seed from which the alfalfa is grown.

Essayists should not overlook the benefit to farmers

who are able to produce more or higher value crops as a result of pollination nor the benefits to the local population from the varied diet to which honey bee pollination contributes.

The scope of the research is an essential judging criterion, accounting for 40% of your score. The number of sources consulted, the authority of the sources, and the variety of the sources are all evaluated.

Personal interviews with beekeepers and others familiar with the subject are valued sources of information and should be documented. Sources, which are not cited in the endnotes, should be listed in a "Resources" or "Bibliography" list.

Note that "honey bee" is properly spelled as two words, even though many otherwise authoritative

references spell it as one word.

RULES:

1. Contest is open to active 4-H Club members only. 4-H'ers who have previously placed first, second, or third at the national level are not eligible; other state winners are eligible to re-enter.
2. Requirements (failure to meet anyone requirement disqualifies the essay) - Preparation for National Judging: Typewritten or computer-generated, double-spaced, 12-pt. Times or similar type style, on one side of white paper following standard manuscript format.
 - Write on the designated subject only.
 - All factual statements must be referenced with bibliographical-style endnotes.
 - A brief biographical sketch of the essayist, including date of birth, gender, complete mailing address, and telephone number, must accompany the essay.
 - Length - the essay proper: 750 to 1000 words.
 - The word count does not include the endnotes, the bibliography or references, nor the essayist's biographical sketch - which should be on a separate page.
3. Essays will be judged on
 - (a) scope of research - 40%;
 - (b) accuracy - 30%;
 - (c) creativity - 10%;
 - (d) conciseness - 10%; and
 - (e) logical development of the topic - 10%.
4. The deadline for entries to be in (not post marked) the Texas 4-H and Youth Development Office is January 31, 2008. Send to:

5. Each state may submit only one entry.
6. Final judging and selection of the National Winner will be made by the Foundation's Essay Committee, whose decision is final.
7. The National Winner will be announced by May 1, 2008.
8. All National entries become the property of the Foundation and may be published or used as it sees fit, No essay will be returned.
9. All entries must have a completed and signed Certification Form as the top cover of the essay.
10. Entries should be securely stapled in the top left corner for submission. Do not place them in folders or report binders.
