Senior Level: Students 12th grade or under

Note: Prior first place winners may not compete in the same category.

No prior year first-place winners or concert performer may compete this year.

Any senior level winner is no longer eligible to participate in this event.

Rules:

3. Students must use original score and perform from memory.
