8 SECTION 9. IMPEACHMENT. Members of the
9 National Board of Directors and other elected officials
10 of the National Fraternity, including regional officials,
11 may be impeached for misconduct or malfeasance in
12 office. Charges shall be submitted in writing to the
13 National Board of Directors. The National Board of
14 Directors shall investigate and hear the charges. If two-
15 thirds of the Members of the National Board of
16 Directors present and voting sustain the charges, the
17 official shall be suspended and removed from office.
18 Those who have been impeached and removed from
19 office shall not be eligible to serve on the National
20 Board of Directors ~~as a Past National President or Life~~
21 ~~Member of the Board~~ unless they are reinstated by a
22 2/3 vote of the National Convention.
23 The National Board of Directors may impose any lesser
24 penalty or take other appropriate action in lieu of
25 impeachment where deemed warranted. Actions
26 constituting formal discipline, such as censure or
27 reprimand, shall require the approval of two-thirds of
28 those Members present and voting.

PROPOSED LANGUAGE

SECTION 9. IMPEACHMENT. Members of the
National Board of Directors and other elected officials
of the National Fraternity, including regional officials,
may be impeached for misconduct or malfeasance in
office. Charges shall be submitted in writing to the
National Board of Directors. The National Board of
Directors shall investigate and hear the charges. If two-
thirds of the Members of the National Board of
Directors present and voting sustain the charges, the
official shall be suspended and removed from office.
Those who have been impeached and removed from
office shall not be eligible to serve on the National
Board of Directors unless they are reinstated by a
2/3 vote of the National Convention.
The National Board of Directors may impose any lesser
penalty or take other appropriate action in lieu of
impeachment where deemed warranted. Actions
constituting formal discipline, such as censure or
reprimand, shall require the approval of two-thirds of
those Members present and voting.

33 PURPOSE: This amendment removes Past National Presidents and Life Members from the Board impeachment policy.

35 RATIONALE: The new language states that any member of the National Board of Directors and other elected officials
36 including regional officials that have been impeached from office shall not be able to serve on the National Board of
