### PRESENT LANGUAGE

8 SECTION 8. NATIONAL SCOUTING AND YOUTH  
9 SERVICES COMMITTEE. The National Scouting  
10 and Youth Services Committee shall consist of ~~a Chair~~  
11 ~~appointed by the National President~~, a representative  
12 of the Boy Scouts of America, and other Members  
13 nominated by the ~~Chair~~ and appointed by the National  
14 President.

16 It shall be the duty of the National Scouting and Youth  
17 Services Committee to advise the ~~National Service~~  
18 ~~and Communication Director~~, the National President,  
19 and the National Board of Directors on relations  
20 between the Fraternity and youth service organizations;

### PROPOSED LANGUAGE

SECTION 8. NATIONAL SCOUTING AND YOUTH  
SERVICES COMMITTEE. The National Scouting and  
Youth Services Committee shall consist of **the National**  
**Scouting and Youth Services Director**, a  
representative **of the National Council** of the Boy  
Scouts of America, and other Members nominated by  
the **National Scouting and Youth Service Director** and  
appointed by the National President.

It shall be the duty of the National Scouting and Youth  
Services Committee to advise the **National Scouting**  
**and Youth Services Director**, the National President,  
and the National Board of Directors on relations  
between the Fraternity and youth service organizations;  
**to coordinate the Fraternity's youth-service**  
**activities, including those related to scouting**  
**organizations, such as the Boy Scouts of America, the**  
**Girl Scouts of the United States of America and**  
**similar associations;** to offer suggestions to enable the  
Fraternity to be of greater service to youth; and to  
promote interest in Alpha Phi Omega among  
professional and volunteer leaders of youth-service  
organizations.

**The National Scouting and Youth Services**  
**Committee shall also work with the National Service**  
**and Communication Committee to promote Scouting**  
**and Youth Services as part of the Fraternities service**  
**program and oversee the National Spring Youth**  
**Service Day and the National Service Week**  
**programs.**

43 PURPOSE: The Scouting and Youth Services Director shall become a permanent Program Director position in order to  
44 expand our Scouting and Youth services and strengthen our relationships with our partner organizations.

46 RATIONALE: This amendment clarifies the duties of the committee and the relationship between the Scouting and
