

PETITION TO FORM A POLITICAL PARTY

Revised Code Sections 3517.01, 3517.011 and 3501.38

NOTICE

"A political party within the meaning of Title XXXV of the Revised Code is any group of voters which . . . filed with the secretary of state . . . a petition signed by qualified electors equal in number to at least one per cent of the total vote for governor or nominees for presidential electors at the last preceding election . . . ".
Revised Code Section 3517.01.

DECLARATION

We, the undersigned, hereby declare that we are qualified electors of the State of Ohio, that it is our intention to organize a political party which shall be known as the Natural Law party, and that it is our intention to participate as a political party in the next succeeding primary election held in even numbered years, which shall occur more than one hundred twenty days from the date this petition is filed in the office of the Secretary of State.
