NOTICE

"A political party within the meaning of Title XXXV of the Revised Code is any group of voters which ... filed with the secretary of state ... a petition signed by qualified electors equal in number to at least one per cent of the total vote for governor or nominees for presidential electors at the last preceding election"

Revised Code Section 3517.01

DECLARATION
