Minutes of the Society Meeting held on December 24, 2006 at 11.00 am

In the final general meeting of the year 2006, the following decisions were taken with the consensus of the members are as follows:

1. Minimum **3 Guards** should be appointed to vigil the members plot 24 hours at the rotational basis **(Local security Services will be contacted)**.
2. Annual fee for security/developmental charges of the area Rs. 5000/- upto one *bigha*, if some one has more than one *bigha*, amount will be charged @5000 per *bigha*. **(Amount can be deposited in two installments)**.
3. Land Records must be kept individually.
4. Society map plan with list of plot holders should be displayed as a board in the enclave area.
5. Primary membership (Rs. 500=00) should be continue.
6. Society should be intimated prior to land transaction, in case of any plot transaction a fix amount should be given to society by both the parties (seller and buyer, amount will be decided in the next meeting).
7. Gram Pradhan of this area (Chandrabani) should be included as member of the society as an Honorary member.
8. Society meeting should be held quarterly basis.
9. Mr. Dinesh Aggarwal, Hon'ble MLA should be invited at the time of next society meeting which is fixed on **7th Jan. 2007 (Sunday)**.
10. It is mandatory to have the boundary wall constructed by land owner and this will be completed by all the members within on month.
