The Secretary of the Society welcomed the members and apprised them about the actions taken as per the decisions of the last meeting. It was informed to the house that already three security guards have been engaged for round the clock security of the area through the local Security Agency i.e. M/s Guardwell Security Services. The construction of boundaries for the plots by individual members is also in progress. Some of the members have already deposited their contributions for the society as agreed during the last meeting.

After this new items of agenda were also discussed and following decisions were taken:

1. Security: It was agreed that the existing arrangements of security (one person on 8 hrs duty) will be continued to have 24 hrs supervision of the area. For the security personnel a temporary cabin will be constructed and put in place somewhere in the middle of the area, so as to have full view of the area. It was also agreed that no new passage will be opened to the area. Further, it was agreed that the local security agency will be requested to engage security guard of the area as from the surrounding villages to the extent possible. The provision of a mobile phone to the security guard will also be explored with the security agency.

2. Electricity: It was agreed that a collective proposal will be taken up with the Electricity Department for taking individual electricity connections and street light in the area. The progress

will be reported in the next meeting. Sixteen members gave their immediate willingness for getting electrical connections.

3. Additional Charges on sale purchase of plots to the Society: It was agreed that for any sale/purchase of plots of the area an additional amount of Rs. 11,000/- will be deposited with the society as an additional charge of the society. This will be in addition to the new membership charge of Rs. 500/-

4. Other Decisions: It was suggested and agreed that the construction of the houses by the individual members will be carried out at the earliest possible.

5. Core Group: It was decided that a Core Group consisting of Shri S.P. Rayal, Shri M.P. Singh, Lt. Col. A. Mishra and Shri B.R. Kamboj will work out an action plan for short term and long term management/development of the area.

6. Next Date of the Meeting: It was also decided that the next meeting of the society will be held in the same venue on **25 February, 2007.**
