Recognizing that most owners will not be traveling more than twelve hours within the harness, designers at Stellar Gravitics lessened the bulkiness of the Slipstream[™] by dropping advanced fuel cells in preference for advanced batteries, and utilized larger grav drive units. Designed for a load of 250kg (including the pilot), the Slipstream[™] is designed to travel at speeds of up to 180kph. (Pilots carrying a minimal load can effectively double that top speed, though flight is difficult to control at such speeds.) Thus, the Slipstream[™] has become the preferred choice of high tech rescue workers, as well as military and paramilitary organizations. With the grav belt's popularity and performance capacities, Stellar Gravitics has also recently started marketing the Slipstream[™] as sports gear for amateur and professional grav belt racing.
