Appointment confirmation is made when a signed copy of this agreement along with your credit card receipt from **PayPal.com** are returned to FrancinesMakeup.com 5125 West Reno Ave., Suite 2045, Las Vegas, Nevada 89118-4913. Upon arrival to Las Vegas, you are required to phone us upon Hotel check-in at 702-808-1686 with the name of your hotel, the phone number along with your room number. At time of services - balance of payments are to be paid in **FULL** in **CASH** only - no charges can be made on location.

\*All Makeup / Hair prices are quoted separate. There is a \$150 minimum for Makeup Services as well as a \$150 minimum for Hair Services ( i.e.: \$300.00 total minimum ). Most instances there will be two ( 2 ) attendants one each for Hair / Makeup ( See Wedding Services / rates at FrancinesMakeup.com if booking on-line. ) You can figure your own price there however, remember there are the two minimums if adding hair. ( Rates are subject to changes at any time. )

\*\* Late charges\* A \$25.00 fee will be charged to your account if appointment is missed or you ( and/or others ) are late to appointed location. Excessive interruptions affecting time schedule of services in excess of 15 minutes will be charged accordingly as well. Deposits are **nonrefundable** if a "no show" exists.

\*\*\* All credit card charges require a physical imprint of card used for payment along with authorized signature at time of services **unless** authorized arrangements have been made. You may pay on-line at <http://www.PayPal.com> using ANY of the above mentioned credit cards including checks there. Use the name **FrancinesMakeup.com** to pay in advance. You must phone us to tell us you used this system to get full credit on your account.

- Balance to be paid in full by **cash - before** start of services. ( Technicians do not carry credit card processors. )
- Balance **charged** on my credit card account as authorized 10 days prior to appointment at **www.PayPal.com**.
