

# Get Don out of prison early!

After many decades of libertarian activism I am a prisoner of the United States for conspiracy to distribute psychedelics (MDMA or ecstasy) and hemp. According to many noteworthy authorities these substances are ancient and scientifically proven means of healing and achieving spirituality. I now must leave this calling in order to find a new means of livelihood to secure my release and help all of us in achieving liberty. Therefore I am seeking your help

I have heard from members of the prison staff as well as my attorney that I may be eligible for an early release to a half way house in March of 2008 rather than spend 6 months to a year extra. This could make me available for work on LP campaigns or any number of worthy projects rather than wasting your tax dollars staying in prison. All this could depend on your help in providing me with a salary based job. Home based work, very temporary or commission only jobs are not acceptable. I seek permanent employment. I believe that a minimum guarantee of at least a few months would be necessary for my release. Could I blog while I work for you?

I would prefer working for some libertarian cause but that is not necessary. I have experience working with food, warehouse work, office work and sales. I do have the background and skills of political campaigns (including Republican and Democrat) I once was opposition researcher and volunteer coordinator for a successful mayoral campaign in the city of Hoboken, NJ. I know Microsoft Office. I have worked well with conservatives as well as leftists and have done fundraising, organized events and petitioning (I may have travel restrictions for a while though). I can give amazing references. Please Google my writings and autobiography for innovative and successful ideas. I could work anywhere in the U.S. but I prefer a blue state or area since they will be less severe on supervision and be more tolerant of my libertarian political activism. They will check any job prospects so serious offers only. Include phone number and best time to call.

It would also be of great help if I had the recommendation of a judge for this release. What is holding me back is a detainer from the state of New Jersey that wants me to do even more time than the 30 months that I have put in already. I got a 10 year sentence with a 42 month minimum before first parole review but this can be changed. The idea is for NJ to drop the detainer

If you are a judge or know of a sympathetic judge contact my attorney Steve Patrizio at 215-569-2121 or email him Do the same if you are offering a job to me and snail mail me a copy of your offer as well. It may be possible for me to leave the halfway house in a short time and lead a somewhat free life reporting to a probation office occasionally.

Then I'll be able to resume blogging and political activism as I have since the 60's. I have written for Liberty and Reason's hit and run blog as well as other libertarian blogs as well as various humor and New Age blogs. It would be difficult to find someone who has had as much experience or as varied in the libertarian movement as I have had. I have been mentioned in 4 books about the 60's including a page in *Radicals for Capitalism*. I helped found the libertarian movement by organizing the draft card burning at 1969 YAF convention which is regarded as our beginning. I look forward to be working with all of you in achieving a libertarian society.
