### **Championship Day Rules**

- **RIDING ATTIRE** (Competition Standard) – ASA 3838 or equivalent approved helmet, short or long riding boots, gloves, collared & sleeved shirt, stock or tie, coat (optional, preferred).
- **ENTRIES** – Each horse may only compete in 2 consecutive levels & no more than 3 tests per horse. One rider only per horse. One rider may ride a maximum of 2 horses in each event.
- **PARENTS must** sign for riders under 18 years.
- **DOGS** – Must be on a leash at all times. Not permitted on arena grounds.
- **DRAW** – It is the competitor's responsibility to check the draw upon arrival as it may vary.
- **SCRATCHINGS** – Please notify any scratching ASAP to help with the smooth running of the competition.
- **CALLERS** – Allowed
- **PROGRAM** – The FSCDA reserves the right to alter the program without notification.
- **CATERING** – BBQ lunch is provided. Tea/coffee is free of charge. Soft drinks for sale.
- **The FSCDA** is not responsible for any damage, loss or injury to persons, animals or equipment.
- **PAYMENT** – Must be made with entry.
- **All riders MUST** complete the EFA Disclaimer Statement or they will not be allowed to compete.
