

Five UCHS art students exhibited at the Washington University Annual High School Art Competition. A junior, Cassie Phillips, was chosen to attend the Missouri Fine Arts Summer Academy.

In 1999, the Varsity Football team won the District championship.

The UCHS Math Club was awarded six trophies during the Hazelwood West Math Tournament. They placed first in State among all large schools on the Power Question at the 1999-2000 High School Mathematics State Contest in Springfield.

Two UCHS seniors **Derrick** Colguitt and Albert McGraw signed letters of intent with the football team of Culver Stockton College of Canton, Missouri. Colquitt serves as a defensive back and running back and McGraw is a linebacker.

The UCHS Marching Band placed first in the Harris Stowe Homecoming Parade, Lincoln University Homecoming Parade and Annie Malone May Day

> Parade. They played at the Kiel Center for three different events.

UCHS business students placed in seven areas in the FBLA District Conference.

Two UCHS Mock Trial Teams won all three judges ballots in area-wide competitions and placed third in regional competition.

Through the UCHS parent/school partnership, \$26,000 was raised to purchase TI-83 Plus graphing calculators for all students in each math class.

FLASHBACKS

1998-99 OUTSTANDING HIGHLIGHTS

- The Mock Trial team earned first place in regional and third in state competition. The students earned more special awards than any other team in the State of Missouri including awards for most outstanding lawyers, witnesses, and defense team.
- ♦ UCHS is an active member of the Distributive Education Clubs of America (DECA). One UCHS student won at state level and went on to compete at the national level.
- ◆ In 1998-99, the Board of Education approved Principal Bender's recommendation to increase the total credits needed for graduation from 22 to 25.
- ◆ Boys Basketball played in the Coca-Cola Shootout, Gateway Classic and the Dr. Martin Luther King Basketball Classic at the Kiel Center! They placed second in the Borgia Tournament and finished second in District competition. The freshman team won Suburban South Conference with a 7-1 record.

BILL BRADLEY VISIT

On February 9,1999, at 9:45 a.m. after five days of scheduling and planning with campaign workers, media, and secret service, Principal Bender led Senator Bill Bradley, then Democratic candidate for President, into the high school gymnasium where he delivered his first address on public education.

MUHL SCHEMMER STADIUM

On May 6, 1999, the School District of University City's Board of Education officially launched construction of a new 400-meter track and stadium by approving plans to rename the stadium after the late Clarence A. (Stub) Muhl (*right*) and the late Henry Schemmer (*left*), two of the most beloved coaches in the district's history since 1928. Muhl, one of the most successful coaches of his time, served as UCHS football coach for 38 years until retirement



in 1966. During that time, he amassed 225 victories and won 20 championships. Schemmer, who served as track coach for 36 years until retirement in 1964, was credited with leading University City track teams to 32 state championships.

OTHER HIGHLIGHTS

In 1997-98, the Boys Basketball team was "back-to-back" conference champions with their coach named Coach of the Year. They placed second in district; 21-6. Two players played on the All-Conference team. One student was on the All-District team. One student was awarded the NBA-WNBA Sportsmanship Award. All graduating seniors played on college basketball teams the next year. Two girls basketball players were awarded the WNBA Sportsmanship Awards.

FIFTH GRADE CLASS REUNION UNDER THE ARCH ATTRACTS NATIONAL ATTENTION

If you can remember what it's like to be eleven years old and full of energy, excitement and anticipation for the future, then you can appreciate the magic created when Ms. Linda Green's 1979 fifth grade class from Jackson Park Elementary (UCHS class of 1986) recently reunited.

Without any reminders, the students came from across the country to complete an assignment that was started 21 years ago. Based on a "Weekly Reader" assignment, Ms. Green (UCHS class of 1965) asked this particular class to imagine what life would be like in the year 2000. On the last day of school, she asked this amazing class to meet her under the Gateway Arch on June 20, 2:00 p.m., 2000.

Alerted by an article in the <u>St. Louis Post-Dispatch</u>, people across the nation watched as ABC's "Good Morning America" broadcast a reunion of the early arrivals. Throughout the day 19 of 31 students arrived at the Arch. They hugged, cried and laughed about the vision their young minds had of the future and how close some of them were in their predictions. The July 10 issue of "People" magazine also carried a story accompanied by a photo of Ms. Green and some of her students inside their old classroom.

Following the publicity surrounding the event, <u>Post</u> reporter Carolyn Bower received numerous e-mails and calls about the heartwarming reunion. A reporter from Indianapolis wrote, "Linda Green was one of the best teachers I ever had..." Another reader commended, "I have never sent a letter or email in response to a newspaper article before. The story about the fifth grade class reunion from Jackson Park School really touched me..."

Another reader said, "Thank you so much for this story. I, too, was in fifth grade in 1979 and to read those things the children wrote brought me back there. I remember writing things like this in my school and a flood of memories came back to me. It made me feel young again. It (the story) took me back to a time when my imagination was all that mattered..." A former Flynn Park student observed, "As I heard KMOX interviewing some people this morning, I almost drove downtown to say 'hi' to my old friends. Most of them graduated from U-City High with me in 1986." He continued, "...U-City is a special place where people bond for life."

That would appear to be true because many people have bonded with Ms. Green, recognizing that her incredibly inspiring style of teaching has made a difference in their lives, as has the pedagogy of so many other exceptional teachers in our district.

KEEPING U IN THE LOOP

The annual Loop in Motion festivities were held on Oct. 13-15 including an Art/ Gallery Walk, the Loop Parade, Taste the Loop, and music/entertainment stages.

The Spirit of St. Louis Marathon took place on Oct. 14 & 15, and passed through the Loop on the morning of the 15th.

An internationally televised Presidential Debate was scheduled for October 17th at Washington University. UCHS student Ashley Crawford is to attend.

The Pageant Theatre complex, on Delmar just east of Skinker now part of the "East Loop," hosted its grand opening on October 19th, featuring Chuck Berry.

The St. Louis International Film Festival will take place November 3-12.

The preliminary plans for a proposed expansion of the University City Recreation Center are being reviewed by our various city boards and commissions, to determine the extent of acceptance and for any suggestions. As a member of the Municipal Library Consortium, U. City residents can now get free library cards for the libraries in St. Louis, St. Louis County, and St. Charles City and County.

The St. Louis County Boundary Commission has accepted our application map for the annexation of Wash. U.'s Hilltop Campus. Public hearings will now proceed, with Commission decision by April 2001.

Listing of available U. City commercial real estate will be posted on the U. City website; <universitycitymo.org>

The City Council approved a conditional use for White Castle to come to U. City, located at the former Long John Silver spot on Olive, between Hanley and Midland. They hope to be open by the end of the year.

Fair-in-the-Square will not be scheduled for next year. The Fair committee will be looking at ways to restructure the event, using input from churches, civic organizations, and neighborhood groups.

COMMUNITY SUPPORTS "CELEBRATION OF THE CENTURY"

On October 29, 1999, more than 300 people gathered at the Sheraton Lakeside Chalet for what will be remembered as University City High School's (UCHS) "Celebration of the Century."

Eric Mink, <u>New York Daily News</u> television critic and UCHS graduate, class of 1965, served as Master of Ceremonies. The same sharp wit and keen sense of humor that keeps Mink's column so popular kept the evening exciting as the first 15 alumni were inducted into the 1999 Hall of Fame. The evening's honorees represented eight decades in the school's history including the late Dr. Richard Sutter - 1927, Elizabeth (Betty Henby) Sutter - 1927, the late Tom "Tennessee" Lanier Williams - 1929, Vaughn "Bing" Devine - 1933, the late Dr. Richard "Dick" Yore - 1935, the late Sara "Sue" (Hirsch) Shear - 1936, Dr. Leonard Williams Levy - 1940, the late Leon Strauss - 1945, Gerald Greenwald - 1953, Glenda (Gerstein) Greenwald - 1956, Bob Gale - 1969, Joel Goldstein -1971, Dr. Renee Ewing Davis - 1974, Wayne J. duMaine - 1983 and Bernard Gilkey - 1984.

The inductees recounted memories of growing up in University City and shared their love of the high school. Bob Gale, screenwriter and producer, reflected, "Making the Senior movie was

instrumental in getting me excited about filmmaking; therefore my career is a direct result of my experience at UCHS... I'm proud of my hometown and happy to be able to make my hometown proud of me." He added, "As a writer, it's an especially great honor to be in the company of Tennessee Williams. I hope that my success and the success of my fellow Hall of Famers will be an inspiration to current and future UCHS students: if we can do it, then you can do it too."

The entire event was like a dream come true to the members of the Muhl and Schemmer families who gathered to remember coaches Stub Muhl and Henry Schemmer. Both men worked side-by-side for most of their adult lives and created some of the most impressive athletic records in the St. Louis area. Many of the audience, including an entire table filled with class of 1948 alumni, were there to share their memories of these two legends. (See Flashback on page 6)


UCHS ANNOUNCES INDUCTEES FOR 2000 HALL OF FAME

In an interesting turn of events, music promoter and business leader **Steve Schankman**, slated to serve as master of ceremonies for University City High School's second annual Hall of Fame induction ceremony, has himself been voted into the elite group. The ceremony, scheduled for Friday, October 20, at 7 p.m., at the Sheraton Plaza Hotel at Westport Plaza, will include 15 inductees for 2000-01.

In addition to Schankman and his business partner **Irv Zuckerman**, both 1966 graduates, the 2000 UCHS Hall of Fame list includes the following: entrepreneur and philanthropist **E. Desmond Lee** - 1936; author and mountain climber **Dr. Thomas Hornbein** - 1948; business leader and community activist **Carolyn Werner Losos** - 1950; Senior Editorial Advisor of Time Warner, Inc., **Jason McManus** - 1952; attorney and community leader **Donald Wolff** - 1955; internationally read journalist **Eric Mink** - 1965; Career educator **Steven Levy** - 1967; trial attorney and author **Michael Kahn** - 1970 and internationally acclaimed pianist **Stan Ford**, **Ph.D**. - 1975.

The following persons will be inducted posthumously: world renowned architect William Adair Bernoudy - 1929; businessman and former president of Stix, Baer and Fuller Louis M. Leipziger - 1929; St. Louis builder and business leader Fred H. Leyhe -1935 and Rabbi Myron Kinberg - 1963.

The Hall of Fame selection process involves a committee of education, community, civic and student leaders from University City. The 2000 Hall of Fame Committee included

business, Schankman, co-owner and co-president of Contemporary Group, a St. Louis-based entertainment agency, still lives and breathes the music that was, and is, in him. You might say that Schankman's career has come full circle, or rather, back around to the University City Loop.

On April 12, Schankman, class of 1966, took time between a major news conference and a meeting with local bankers to solidify an agreement to serve as master of ceremonies for the second annual UCHS

Hall of Fame event. He will follow New York Daily News reporter Eric Mink as the second alumnus to host the prestigious banquet at his alma mater. "The reason I agreed to do it (Hall of Fame 2000) is that I grew up in University City. I thought, even then, that University City Schools were the best in the country."

Schankman, along with fellow alumnus and business partner Irv Zuckerman (class of 1966), oversees the operations and management of Contemporary's subsidiaries: Contemporary Productions, Contemporary Entertainment and Contemporary Marketing. Over the past 32 years, these three components have positioned Schankman and Contemporary as leaders in the entertainment, promotion, special event and corporate marketing fields.

The Schankman and Zuckerman partnership began back in first grade at Daniel Boone Elementary School (now Barbara C. Jordan). Two years after high school graduation, the two friends went into business as agents for local and regional bands. "I was playing trumpet at the time and getting ready to go to law school." Contemporary has become one of the largest entertainment producers in the United States. It recently merged with New York-based SFX Entertainment, the world's largest fully-integrated live entertainment company. Perhaps Schankman's greatest source of pride is the Riverport Amphitheater, an openair, 20,000-seat arena built in 1991. "The theater marked a big time in our lives when we were able to attract notable recording artists into St. Louis." The company also operates the

Next to Steve Schankman's 1966 "Dial" yearbook photo, you will find the saying, "Let not the music that is in us die." Thirty-two years after beginning his first 18,000-seat Sandstone Amphitheater in Kansas City and provides consulting services to various other entertainment facilities around the country.

Schankman's latest business venture pairs him with local University City businessman. Joe Edwards. The new Pageant Theater, a live music nightclub, is scheduled to open in the fall of 2000. (*See Loop article on page* 5.) The Pageant Theater is the latest in a string of projects that have enabled Steve Schankman to give back to his hometown. "As a kid who grew up in University City and did pretty well in life, I always look back to where I came from and have to credit that school system for the education I received in the early years." He added, "Whenever there is something going on, something to do with schools, they always know they can count on me."



Many encores were called for as a large crowd gathered in University City's Market in the Loop on Tuesday, July 25. Many of them were eager to be a part of the informal reunion of University City High School alumni musicians. Others were simply drawn by the sound of music resonating from the heart of the City.

It was a special night for businessman and musician Steve Schankman (class of 1966), who had organized the evening as a tribute to Dr. Roger Warner, the former band instructor at UCHS. Schankman and fellow classmates came together to show Warner that they had not lost their talent nor their enthusiasm and had remained true lovers of music. It was also a special night for UCHS Senior Anthony Westbrook, a current UCHS band student, who was also a beneficiary of the night of music. With the help of UCHS band director Rhonda Harper, Schankman was able to surprise the young man with a gift of a brand new trumpet. According to Schankman, this is the start of a tradition at the high school, which will serve to preserve the legacy of Dr. Roger Warner and the Class of 1966.

ALUMNI CLASS NOTES

During recent Founder's Day Observances at Washington University, two University City High School alumni were honored. Founder and former chairman of the Lee-Rowan Company **E. Desmond Lee**, UCHS class of 1936 and 2000 UCHS Hall of Fame inductee (*See story on page 6.*), received the prestigious Robert S. Brookings Award and **Ned O. Michael Kovac, 63 (class of 1955), a co-founder of the UCHS Reunion Scholarship fund, passed away on August 16 in his home



after a long illness. He was an intellectual property attorney with the Polster Lieder Woodruff and Lucchesi law firm. Prior to joining this firm, he was a private practice attorney for 12 years and owned an import business. Kovac was also a composer who wrote patriotic and spiritual songs. Several of his works were performed at the 1980's Fair St. Louis. He was an elder at Central Presbyterian Church in Clayton.

Michael Kovac Class of 1955

Renowned news reporter and author **Bob Tamarkin**, 62 (class of 1956), died of a heart attack on April 11, 2000. Tamarkin earned a bachelor's degree from Washington University in 1961 and a master's degree in

journalism from the University of Missouri in 1963. He relocated to Chicago and began reporting for the <u>Chicago Daily News</u>. Twenty-five years ago, serving as a correspondent for the newspaper, Tamarkin was, by his own account, "…the very last correspondent evacuated when Saigon fell to the North Vietnamese on April 30, 1975." He considered the story he filed after that helicopter ride to be the most important account he had ever written on the Vietnam war.

Harvey Reznick, 57 (class of 1960), chief of adversary proceedings for the Army's Aviation and Missile Command, died in his sleep of an apparent heart attack. He was lawyer with the Aviation and Troop Command in St. Louis from 1972 to 1997, serving the last two years as chief council for the command. In 1997, he became part of AMCOM in Huntsville, AL. However, he and his family kept their residence in the St. Iouis area. He was an avid tennis player and recreational swimmer and member of Shaare Zedek synagogue in University City.

Michael Brewen, 51 (class of 1967), died at his residence in Farmington, MO, of ALS (Lou Gehrig's disease). He was an educator and long-time college basketball mentor. He graduated from Denver University and received his MA from Purdue. He coached basketball at Wabash College, IN; University of Nebraska -Omaha; Wayne State College, NE and Mineral Area College. At MAC he was a political science instructor and received two honors in 1998: the Governor's Excellence in Teaching Award and the MAC Outstanding Faculty Member of the Year award. His parents are Lloyd and Alice (Mitchell) Brewen and sisters are Linda Schnurbusch of Independence, KS, and Sally Breuer of Alton, IL..
