

CONTACT INFORMATION FOR STATE AND NATIONAL LEGISLATORS

Elected officials pay close attention to constituent mail. Personally signed mail receives more attention than generic letters with multiple signatures. Electronic mail may be used if there is not enough time for a personal letter or if a faxed letter is not feasible. Below is contact information for elected officials for Norbertines of St. Norbert Abbey. You may track national legislation through Thomas (Thomas.loc.gov), the legislative Web server for the Library of Congress. **Note that mail intended for DC legislators should be sent to a home state office of the legislator.** All envelopes addressed to the US Congress take over three weeks due to irradiation procedures. If you send a letter to the state office, the state office usually bundles the mail and sends to DC without using US postal service.
