NARRATIVE AND ADDITIONAL INFORMATION:

On Friday, December 22, 2006 at approximately 1800 hrs the Boston Properties Control Center received a report of an assault occurring at Au Bon Pain located at 800 Boylston Street, Boston. At that time the BPCC contacted Special Officer Gilbo to respond to the scene. At approximately 1805 hrs SPO Officer Gilbo arrived at Au Bon Pain and witnessed a female later identified as Senethra Taleese Anderson yelling at an employee of Au Bon Pain. At that time the manager of Au Bon Pain, Younes Gassab, said that the female suspect had assaulted an employee of the store. Officer Gilbo identified the victim as Liliana Rivas, who had bruises on both her right and left arm and a cut just below the right side of her lip. According to Mr. Gassab the suspect had shoplifted several food items, cookies and chips, with approximately value of \$5.00 and exited the store. At that time Ms. Rivas attempted to question the suspect outside of the store in a common seating area. The suspect at this point according to Ms. Rivas started yelling at her and came up to her and grabbed hold of her arms. After speaking to both Ms. Rivas and Ms Anderson SPO Officer Gilbo placed Ms. Anderson under arrest for shoplifting and assault and battery.
