**Complaint Regarding Richmond Randolph Lodge No. 19 Election December 10, 2005**

Most Worshipful Sir:

This letter of complaint is with regards to certain irregularities that occurred in the election of the Worshipful Master of Richmond Randolph Lodge No. 19, Richmond, Virginia on December 10, 2005. Right Worshipful Guy M. Blankinship, III, District Deputy Grand Master for District 15-B was in the East for the elections.

There were two nominees for Worshipful Master: Br. Douglas G. Mack, Senior Warden and Br. Thomas E. Breeden, Senior Steward.

After the two nominees retired the ballots were distributed and balloting begun with no discussion being permitted prior to the balloting.

On the return of the nominees they were not given the opportunity to ballot. Rather, the results were announced immediately after they approached the Altar.

This is a violation of **Sec. 2.40** of the *Methodical Digest*: **“The nominees shall retire before any discussion or ballot. When the ballot is collected, they may return to the Lodge room and shall then be permitted to vote.”**

By this letter of complaint I am requesting your review of this matter and appropriate steps taken to remedy it.

### **Complaint Regarding Behavior of Certain Brothers at Richmond Randolph Lodge No. 19**

Most Worshipful Sir:

This letter of complaint is with regards to the behavior of certain Brothers, including the Worshipful Master, at Richmond Randolph Lodge No. 19 – behavior that may result in the preferring of Masonic Charges.

Certain Brothers, including the Worshipful Master, clandestinely conspired and engineered the election of the Senior Steward as Worshipful Master rather than the Senior Warden due to the fact the Senior Warden is an openly gay man.

The issue of me being an openly gay man was dealt with last December by Right Worshipful J. Larry Dixon and Grand Lodge. Attached is my letter of December 20, 2004 to Right Worshipful Dixon after the resolution.

The action of the Brothers is in direct conflict with their **most solemn obligation** they took when being Raised as Master Masons wherein they swore not to supplant a brother Master Mason in any of his lawful undertakings or speak evil of his good name.

The action is also in violation of **1909 D-18, §-1.29, §2.31**: **“To the question: ‘How should a member be dealt with who comes out and electioneers to have himself elected to office?’ I replied, ‘Every member, as a matter of conscience should vote against him.’ (J.W. Eggleston).”**
