RENTAL TERMS AND CONDITIONS:

- 1. All fees are in United States Dollars, made out to above-named holter owner. Fee of \$_____ will be assessed for any returned checks in addition to bank fees and are due immediately.
- 2. Rental fee of \$_____ for ten (10) days is payable prior to delivery of equipment; rental term begins on date of OWNER’s receipt of signed contract/fees and ends upon OWNER’s receipt of returned equipment. Rental includes the use of the monitor, case, leads and one test kit. Additional test kits for multiple dogs are available for \$_____ each, in addition to stated rental fee. A deposit of \$100 is necessary to be refunded upon return of the unit, subject only to damage, loss or late fees. Reading of the tape is NOT INCLUDED with the rental and must be separately secured by RENTER.
- 3. The equipment shall be delivered to RENTER and returned to OWNER at RENTER’s risk, cost and expense, using USPS PRIORITY MAIL, DELIVERY CONFIRMATION and \$600 INSURANCE. Rental fee billed to the RENTER for the full term, even if the equipment is returned before the end of the term. If the equipment is not returned by the end of the term late charges shall accrue at \$_____ USD per day and are due immediately.
- 4. RENTER shall take all due care to protect equipment from damage due to any cause including but not limited to other animals, inclement weather or shipping. RENTER has 24 hours to notify OWNER or USPS of damage upon receipt of equipment.
- 5. RENTER shall pay OWNER full compensation for replacement and/or repair of any equipment not returned because of loss, or any equipment damaged and requiring repair. A written estimate or invoice for replacement/repair is conclusive as to the amount RENTER shall pay under this paragraph, same not being less than \$500 for monitor and \$50 for leads.
- 6. RENTER shall not remove the equipment from the address of RENTER or the location shown herein as the place of use of the equipment without prior written approval of OWNER. RENTER shall inform OWNER upon demand of the exact location of the equipment while in RENTER’s possession.
- 7. No allowance will be made for any rented equipment or portion thereof claimed as unused. Acceptance of returned equipment by OWNER does not constitute a waiver of any of the rights OWNER has under the rental agreement.
- 8. RENTER shall allow OWNER to enter RENTER’s premises where the rented equipment is stored or used at all reasonable times to locate and inspect the state and condition of the rented equipment. If RENTER is in default of any of the terms and conditions of this agreement, OWNER and his agents, at RENTER’s risk, cost and expense may at any time enter RENTER’s premises where the rented equipment is stored or used at any time and recover the rented equipment.
- 9. RENTER shall not pledge or encumber the rented equipment in any way. OWNER may terminate this agreement immediately upon the failure of RENTER to make rental payments, or upon RENTER’s filing for protection from creditors in any jurisdiction.
- 10. OWNER makes no warranty of any kind regarding the rented equipment. RENTER shall indemnify and hold OWNER harmless for all injuries or damage of any kind for repossession and for all consequential and special damages for any claimed breach of warranty.
- 11. RENTER shall pay all reasonable attorney and other fees, expenses and costs incurred by OWNER in protection her rights under this rental agreement and for any action taken by OWNER to collect any amounts due under this rental agreement.
- 12. This writing constitutes all agreements between OWNER and RENTER(S). By signing this agreement, RENTER signifies complete understanding and agreement of all above described terms and conditions.
