1) When you promote a branch during the qualification period the Sales and QNCs of the New Branch will count in your Central Branch Numbers.

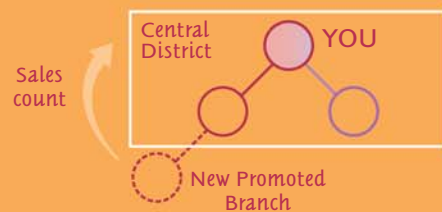


2) When this new Manager promotes a New Branch during the qualification period, the Sales and QNCs of this New Branch will also count in your Central Branch Numbers.

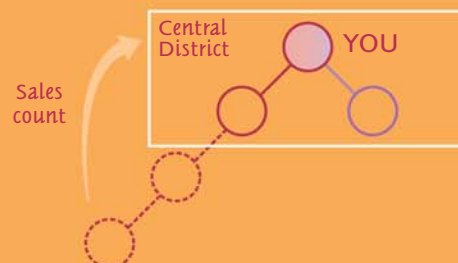


INDIRECT BRANCHES:

JAFRA SUMMER TRIP 2006

EVENT REGISTRATION

1. Jafra Summer Trip 2006 qualifications can be earned between February 1, 2006 and May 31, 2006.
2. The Event Package includes a 3-nights/4-days stay at the Sheraton Baganvillas Resort. The hotel rooms will be based on double occupancy. Please note that no more than 2 attendees will be allowed to stay per room and rollaway beds will not be permitted at this event.
3. The Event includes the following activities and meals:
August 3: Welcome Reception
August 4: Training, breakfast, lunch, and awards banquet
August 5: Free day, breakfast, lunch and a dinner allowance
August 6: Closing session and breakfast
4. Jafra Identification Wristbands will be issued during the Event Registration and it will be mandatory for attendees to wear them throughout the event. Only those who have been issued a Jafra Identification Wristband will be allowed into official Event functions.
5. Ground transportation to and from the Puerto Vallarta International Airport and Sheraton Baganvillas Resort **will only be provided for Level 2 winners and above.**
6. Consultants who qualify for the Event will be mailed a letter confirming the level earned for self (and guest if applicable) along with registration form(s). Confirmation mailing will be sent out the week of June 5, 2006. Forms must be received at Jafra by June 23, 2006.
7. Only Consultants who have qualified for the Event for themselves and a guest are authorized to pick up their own and guest Event Badges at Event Registration. **Please note that a valid form of photo identification will be required when you register with Jafra and when you register with the Hotel.**
8. Guests of Jafra Event attendees must be at least 18 years old. No children (with the exception of attendees who are nursing mothers) or unregistered persons will be admitted into the Jafra Event.
9. A Consultant's Jafra account must be current to attend Jafra Summer Trip 2006.
10. If an Event Qualifier chooses to stay at the Sheraton Baganvillas Resort for any additional days following the event, the Consultant is responsible for making his/her own reservations and the hotel must be paid directly. Take advantage of the Jafra Summer Trip 2006 special rate by calling 800-433-5451 by July 3, 2006. The special rates cannot be guaranteed after this date. The rates are \$95.00 per night, plus 17% tax for single or double occupancy and is based on space availability. Please note that this special rate is not available prior to the event start date of August 3, 2006.
11. Consultants, Managers, District Managers and District Directors must achieve required sales based on the level desired to earn in order to be eligible to qualify and attend the Event. A Consultant and above may not attend the Event as guests of other Consultants, regardless of start date.

AIR TRAVEL RESERVATIONS

1. Qualifying for the Jafra Event Air Package entitles you (and your guest if applicable) to a round trip, standard coach accommodation(s) at the lowest applicable airfare provided to Puerto Vallarta International Airport in Puerto Vallarta, Mexico and originating from the predetermined Gateway Cities listed below. The flight must depart the Gateway City and must arrive at the Puerto Vallarta International Airport on August 3, 2006 and return to the Gateway City on August 6, 2006. An overnight flight will be considered if it is the lowest available flight and the arrival time is considered appropriate by Jafra.
2. There will be no substitutions or reimbursements for Level Two winners and above who will **not** be utilizing the air travel portion of their winner's package.
3. A Self-Air Travel Reservation Form and a Guest Air Travel Reservation Form, if

applicable, will be mailed to you along with your Event Registration Form and Confirmation, which will be mailed the week of June 5, 2006.

4. Any request to extend a stay beyond the dates listed above, fly from a non-Gateway City, and use alternative flight times or a preferred airline will be at the Consultant's expense if such request causes the airline ticket to exceed the lowest available airfare designated by Jafra. If such request causes the ticket to be of equal or lesser value to that of the lowest available airfare designated by Jafra, the request will be granted at no additional cost to the Consultant.
5. If the Consultant qualifies for a Guest Air Package, the guest's airfare is defined as originating from and returning to the same Gateway City as the Consultant. If the guest is required to fly from a different city other than that of the Consultant, the Consultant is responsible for any additional cost over the cost of the Consultant's ticket. If the guest's ticket is of equal or lesser cost, then there will not be any additional cost for flying from two separate points. No refund will be granted for a ticket that is of lesser cost than that of the Consultant.
6. If there is no Jafra approved Gateway City within a 180-mile radius of the Consultant's legal Jafra address, Jafra reserves the right to designate the airport within a 180-mile radius of her/his legal Jafra address that the ticket will be purchased from. If the Consultant chooses a different airport than the one designated, she/he will be responsible for any increase in airfare over that of the ticket from the designated airport.
7. Jafra will not reimburse Consultants for airline tickets purchased from agents other than Jafra Travel Headquarters.
8. If tickets are issued to the Consultant and the Consultant cancels, the unused tickets must be returned to Jafra Headquarters.

PASSPORT INFORMATION

1. United States Citizen Guests will need a photo I.D. and proof of citizenship (Passport, original Birth Certificate or copy of Birth Certificate with raised seal - must have raised seal to be valid, no Xerox copies will be accepted). The following photo ID cards are acceptable; a federal, state, or local government issued picture ID card; state driver's license; or an ID card issued by a private identification card citizenship, etc., required for boarding and reentry into the United States. (A voter's registration card or a Social Security card is not acceptable proof of identity).
2. All Non-US Citizens and Resident Aliens of the United States need both a passport and a valid Alien Resident 9ARC or green card.
3. Aliens need a valid Passport and a valid Multiple Re-Entry Visa.
4. To expedite travel time through customs, it is strongly recommended to use a passport.

MISCELLANEOUS

1. Inquiries to Consultant Services must be made no later than July 14, 2006.
2. Jafra Event and Air Reservation Forms must be received at Jafra Headquarters no later than June 23, 2006. If a form is received after this date, the Consultant will be responsible for any additional cost to the ticket resulting from the late booking and a \$25.00 late fee will automatically be charged to the Consultant's Jafra account.
3. Once a reservation form has been received at Jafra Headquarters, any changes will be subject to a \$25.00 fee per change, which will be charged automatically to the Consultant's Jafra account. No documents or tickets will be mailed until that fee has been paid in full to Jafra. This fee is in addition to any ticket change fee, which will be the Consultant's responsibility and must be received at Jafra Headquarters prior to any ticket reissue or mailing.
4. There will be no monetary compensation for Consultants who do not utilize the Jafra Summer Trip 2006.

* Attendance to U.S. Division summer event is only for Consultants and Managers and above in Jafra U.S. Division. (to include Regions 41, 42, 43, 44, 45, 46) as of January 1, 2006.
