1. The City of Caloocan, through the *General Fund of the 2006 Annual Budget of the City as per Sanguniang Panlungsod Ordinance No. 1102 s. 2005* intends to apply the sums listed above being the Approved Budget for Contract (ABC) to payments under the contracts for the infra projects named above. Bids received in excess of the ABC shall be automatically rejected at Bid opening.

Project: 55 infra projects

2. The City of Caloocan now calls for the submission of Letters of Intent (LOIs) from potential Bidders to apply for eligibility for the above named infra projects. Bidders should possess a valid PCAB license applicable to the above type and cost of the contract, have completed a similar contract with a value of at least fifty percent (50%) of the ABC, and meet the other minimum eligibility requirements stated in the Eligibility Documents. Interested Bidders must submit their LOIs on or before *December 5, 2006 at 4:00 pm* at the *BAC Secretariat, Office of the Bids and Awards Committee, 2nd Floor, Caloocan City Hall, A. Mabini St., Caloocan City* and secure the Eligibility Documents therefrom. Applications for eligibility will be evaluated on a "pass/fail" basis. The last day for the submission of the accomplished Eligibility Documents shall be on the date of the opening of Eligibility Documents: *December 6, 2006 at 4:30 pm* at the *BAC Office*. Only those Bidders passing the eligibility check will be entitled to purchase the Bidding Documents.
3. Bidding will be conducted through open competitive bidding procedures as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act," and is restricted, unless otherwise stated, to organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines. In accordance with the IRR-A of R.A 9184, only Bids from eligible Bidders will be opened. In accordance with the IRR-A of R.A. 9184 a contract will only be awarded to the Lowest Calculated and Responsive Bidder who was determined as such during post-qualification.
4. Interested Bidders shall submit their accomplished Eligibility Documents to the *BAC Secretariat* at the *BAC Office, 2nd Floor, Caloocan City Hall, A. Mabini St., Caloocan City* on or before *December 6, 2006 at 4:30 pm*.
5. Interested eligible Bidders may obtain further information from the City of Caloocan and inspect the Bidding Documents at the address given below from *8:00 a.m. to 5:00 p.m.* during working days.
6. A complete set of Bidding Documents may be purchased by Bidders that passed the eligibility check upon the presentation of the Notice of Eligibility to the BAC Secretariat, at the address below and upon payment of a nonrefundable fee of *Five Thousand Pesos (P 5,000.00)*. The Bidding Documents shall be received personally by the bidder or his authorized representative on or before *December 7, 2006*.
7. The City of Caloocan will hold a Pre-Bid Conference open to all Eligible Bidders on *December 7, 2006 at 2:30 pm* at the *Office of the Bids and Awards Committee, 2nd Floor, Caloocan City Hall, A. Mabini St., Caloocan City*.
8. Eligible Bidders must submit their Bids at the *BAC Secretariat, Office of the Bids and Awards Committee, 2nd Floor, Caloocan City Hall, A. Mabini St., Caloocan City* on or before the *above listed schedule*. All Bids must be accompanied by a Bid security in any of the following forms:

or an equivalent amount in a freely convertible currency. Late Bids shall not be accepted. Bid opening shall be held *at the Bidding Room of the Bids and Awards Committee, 2nd Floor, Caloocan City Hall, A. Mabini St., Caloocan City* in accordance with the *schedule listed above*. Bids will be opened immediately thereafter in the presence of the Bidders' representatives who choose to attend at the address below.

In case the above mentioned schedules are declared as *non-working days*, the affected activities will be held on the *following working day* at the designated time.

9. Other relevant requirements or documents deemed necessary by the City of Caloocan are listed in the Bid Data Sheet (**BDS**)

10. Completion of the Works is required within *the contract duration listed above, starting from the date of receipt of Notice to Proceed.*
11. The City of Caloocan reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
