ACKNOWLEDGMENT OF RISKS AND RELEASE OF CLAIMS

I hereby acknowledge that my family and I desire to participate in the functions and activities of the Lafayette Newcomers Club (the "Club"), and I understand that the Club is a voluntary organization conducted without profit for the benefit of its members. I further understand that:

- The activities of the Club often take place in an active environment that may involve risk to myself and my family.
- The Club does not require that my family or I participate in any of its functions or activities.
- The Club requires me to be responsible for the safety and conduct of myself, my family members and any of my quests, while involved in any Club functions or activities.
- The Club requires all other members to be similarly responsible for themselves, their families and their guests.
- The Club makes no representations or warranties regarding insurance coverage for any member, participant, host, sponsor or facility in connection with the Club's functions or activities.

Therefore, I agree as follows:

- I hereby release and forever discharge each of the Club, its directors, its agents and its representatives from any and all claims, suits, demands, obligations and liability of any nature for any injury, damage, loss, cost or other detriment of any kind, known or unknown, fixed or contingent, that arises out of or with respect to the participation by me or my family in the Club and its functions and activities.
- I agree to hold harmless and indemnify the Club, its directors, its agents and its representatives for all costs and liabilities, including attorney's fees, resulting from my, or my family's participation in this Club.
- I accept that participation by me and my family in the Club is voluntary, and I assume all risks related to my and my family's participation in the Club and all such risks to individuals for whom I am responsible.
- I acknowledge familiarity and understanding of section 1542 of the California Civil Code, which provides as follows:

A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor.

To the extent that section 1542 or any similar law or statute may otherwise apply to this waiver, I hereby waive and relinquish as to all matters released hereunder all rights and benefits that my family or I have, or my have, under Section 1542 of the California Civil Code, or under the laws of California or any other jurisdiction to the same or similar effect.

This release and its rights and obligations of the parties hereunder shall in all respects be governed by and construed in accordance with the laws of the State of California, without giving effect to its principles of conflicts of laws. This release shall be effective as long as I or my family participate in the functions and activities of the Club. The terms and conditions of this release shall be binding upon the executors, administrators, heirs, successors and assigns of my family and me.

I have carefully read each of the provisions of this document, and I know and fully understand the contents of this document. I understand that this release shall be binding upon my family our assigns and me.
