Memory <sup>and</sup> not acting under duress menace fraud  
or undue influence of any person whatever do  
Make publish <sup>and</sup> declare this to be my last will  
<sup>and</sup> Testament in manner following that is to say  
First

I direct that my body be decently buried with  
proper regard to my Station <sup>and</sup> Condition in life  
Secondly

I direct that my executor hereinafter  
named as soon as he may have sufficient funds  
belonging to my estate in his hands pay my  
funeral expenses <sup>and</sup> the expenses of my last  
Sickness <sup>and</sup> any <sup>and</sup> all allowance made to my  
family

Thirdly

I give <sup>and</sup> bequeath unto my wife Catherine  
O'Grady <sup>and</sup> to my son Daniel O'Grady for my  
homestead consisting of lots Twenty four <sup>and</sup> Twenty  
five (24 & 25) Situate in Block fourteen (14) in  
the town of Waller ville Silver Bow County  
Montana Territory <sup>and</sup> the dwelling house in the  
same <sup>and</sup> also an undivided one third of  
in <sup>and</sup> to that certain quartz Lode known as  
the Ridge Lode the same being designated in  
the Spec of the Surveyor General for Montana  
as Lot No 250 a portion of Section Seven in  
Township Three North of Range Seven (7) West

of the principal Meridian for Montana Territory  
located in Summit Valley Mining District  
Silver Bow County Montana Territory  
Fourthly.

I give and bequeath unto my son George  
F. O'Grady an undivided one third of in and  
to that certain quartz lode Mining Claim  
known as and called the Gallatin lode situated  
in Summit Valley Mining District Silver  
Bow County Montana Territory the adjoining  
Claim on the ~~west~~ east of said Claim is known  
as the Eclipse lode

Fifthly

I give and bequeath unto my wife Catherine  
O'Grady all my household and kitchen furniture  
and other personal property owned by me

Sixthly

I give and bequeath to my wife and  
all my children I share and share alike  
all of that certain tract of land consisting  
of about of two lots and two houses situated in  
the South East Corner of Chestnut and Jackson  
Streets in Scranton Pennsylvania and  
all my right title and interest in and to the  
same

Seventhly

I hereby designate my son Daniel  
O'Grady the executor of this my last will and  
testament and authorize him under the  
provisions of law to carry out and execute  
the same
