

## **PETITION FOR IMPEACHMENT**

THESE PETITIONERS NAMED BELOW HEREBY GIVE THEIR POWER BY CONSENT TO THE IMPEACHMENT OF JUDGE XXXXXX XXXXX, FORMERLY A JUDGE OF THE UNITED STATES DISTRICT COURT FOR THE STATE OF XXXX, FOR GOOD AND JUST CAUSES, INASMUCH AS IT IS RECOGNIZED BY THE PEOPLE THAT SAID JUDGE XXXXX HAS COMMITTED THE CRIMES OF MISPRISION OF TREASON, GOING ALSO TO TREASON, AND THE CRIME OF MISPRISION OF FRAUD, A FRAUD, WHEREBY OVER 70 CHARGES OF FRAUD, ALONG WITH THE EVIDENCE THERETO, WAS MADE KNOWN UNTO SAID JUDGE XXXXXXXX, AND OF THE OFFENSE IN VIOLATION OF ARTICLE III, SECTION 1 OF THE UNITED STATES CONSTITUTION OF BAD CONDUCT, OR BEHAVIOR, AGAINST THE CONSTITUTION OF THE UNITED STATES, WHETHER IN WHOLE R IN PART.

THAT JUDGE XXXX XXXXX WAS ADVISED THAT THE IRS FEDERAL AGENCY HAD ENGAGED IN AND HAD COMMITTED A NUMBER OF SERIOUS CRIMES INVOLVING FRAUD BY CONCEALMENT, OR HIDING, A SIGNIFICANT NUMBER OF SUCH SAID OFFENSES, FRAUD BY DECEPTIVE APPEARANCES OF FACT, 4 OR MORE COUNTS, COVER UP, AT LEAST50 COUNTS, TREASON, COLLUSION AND CONSPIRACY TO COMMIT TREASON, ALL FOR THE PURPOSE OF FURTHER COMMITTING THE CRIMINAL OFFENSE OF THEFT BY DECEPTION.

THAT JUDGE XXX PREVENTED AND SUPPRESSED ADDITIONAL EVIDENCE IN THE CASE FROM BEING BROUGHT FORWARD AND SUBMITTED BEFORE THE COURT FOR TRIAL BY JURY, IN VIOLATION AND PREJUDICE AGAINST ARTICLE III, SECTION 2, CLAUSE 3 OF THE CONSTITUTION, BY DISMISSING THE CASE AGAINT THE DEFENDANT IN A LEGAL PROCEEDING WHICH RECOGNIZED THAT THE DEFENDANT WAS PLEADING GUILTY TO ALL THE CHARGES BY SO PLEADING, ALSO VIOLATING WITH PREJUDICE THE FIFTH AND SIXTH AMENDMENTS TO THE CONSTITUTION OF THE UNITED STATES.

THAT ANY SUCH ACTS THAT DO NOT CONSTITUTE GOOD CONDUCT MUST CONSTITUTE BAD CONDUCT, AND THAT THESE ACTS BY DAVID JUDGE XXXX XXXXX HAVE THE ABILITY TO AFFECT ALL CITIZENS THROUGHOUT THE UNITED STATES.

THAT BAD CONDUCT IS A CHARGEABLE OFFENSE BY CONGRESS ON BEHALF OF THE PEOPLE OF THE UNITED STATES UNDER **ARTICLE III, SECTION ONE**.
