Great Turn Out for Stream Sweep

The 7th Annual Leading Creek Stream Sweep was held on April 21st in conjunction with Earth Day. We were thrilled with the turnout of 35 volunteers, who met at the Rutland Jim Vennari Park.

The Leading Creek Stream Sweep has faced high water, cold temperatures and spring rainstorms during much of its history. But on this April morning there wasn't a cloud in sight as 35 volunteers of all ages turned out to help clean up the Leading Creek watershed. Volunteers filled two dump trucks, belonging

to the Rutland Township
Board of Trustees, with
trash collected from
throughout the watershed.
Clean up locations ranged all
around from Albany,
Langsville, Rutland,
Bradbury, and Laurel Cliff.

For their service, volunteers received a new Leading Creek Stream Sweep T-shirt and pizza for lunch.

Field Trip Along Little Leading

Several field trips with local schools were organized by the Meigs SWCD in the last few months of the school year, including one that brought nearly 70 area 5th grade students to Little Leading Creek at the Meigs SWCD Conservation Area for a field day. On May 15, students from Meigs Elementary came out to New Lima Road and spent the day learning about many aspects of conservation. Meigs SWCD staff organized a series of activity stations for

teachers to bring students to during the day. The lessons included Macroinvertebrates: Bugs in the Stream, Water Quality Investigations, Wildlife Pelt Identification, and a special tree planting of native American Chestnut trees. Students and teachers alike were able to explore the Conservation Area and walk the Nature Trail there.

Cleaning Up Where Leading Creek Ends Up

On June 16 the 2007 Ohio River Sweep kicked off with the dash of enthusiastic volunteers and loads of trash bags. The Meigs Soil and Water Conservation District organized three locations in Meigs County this year, and many other groups sponsored clean up sites all along the river. In Pomeroy volunteers met at the amphitheater in the riverside parking lot, and in Racine volunteers met at Star Mill Park. A new location this year was Portland, where volunteers met at the school that has become the Portland Community Center. Between the three sites, nearly 80 volunteers turned out for the event. At 9am volunteers picked up trash bags at each

site and headed out to make the community look a little brighter. All trash was brought back to the meeting locations and disposed in trucks provided by the village or the township. Volunteers were then treated to lunch at noon and received a new River Sweep T-shirt.

This was the 19th Annual Ohio River Sweep. River Sweep is a riverbank cleanup that extends the entire length of the Ohio River and beyond. Some tributary streams are also gradually being added to the list of clean up sites. All counties along the Ohio River participate in this extensive day of cleaning up litter. This year our partners of the

Ohio River Sweep included the Ohio River Valley Water Sanitation Commission (ORSANCO), the Village of Pomeroy, Village of Racine, Village of Portland, Portland Community Center, Lebanon Township Trustees, the Meigs Transfer Station, Jay Hall Jr., and Ohio Valley Bank.

- Water the garden between 4pm and 9am when there is less evaporation risk.
- Gardeners can skip a day or two of watering in a

- week without a serious threat to plants.
- Plant hardy, native trees and plants that don't require as much water.
- Mulch plants to retain water.
- Check your faucets or hoses

- regularly and repair any leaks immediately.
- Use a pool or spa cover to reduce the amount of water that evaporates.
- Always be sure to respect local water usage limitations and warnings.
