Wetlands of the Watershed Tour

Celebrate American Wetlands Month by exploring the wetlands of the Leading Creek Watershed. On Thursday, May 8th from 5 to 8p.m. the Meigs Soil & Water Conservation District and the Leading Creek Watershed Group will sponsor the Wetlands of the Watershed Tour and Picnic.

This free watershed tour will include three unique wetlands and end with a picnic. Meet us at the first stop on the tour, the Wilson Wetland on State Route 7 near Middleport and Hobson. At 5pm presenters from the Cooper Hollow Wildlife Area will tell the story of the Wilson Wetland and show off the varied wildlife there. At 6pm we will meet staff from the Ohio Department of Transportation and tour the Fairgrounds Wetland Mitigation Area that also has an acid mine drainage treatment system incorporated into the wetland. At 7pm we will end the tour at the Meigs SWCD

Conservation Area with a tour of the wetland enhanced there in 2007. Participants will then enjoy a cookout and picnic and have the chance to explore the Conservation Area further, including the hiking trails.

Watershed Public Meeting

On Wednesday June 24th, from 6:30 to 8:30 pm, the Huntington District of the Army Corps of Engineers will be presenting a study on water resource concerns in Meigs County. The meeting will be held at the Pomeroy Library, and is being hosted by Rural Action.

Members of the general public, as well as community leaders, resource professionals, and other stakeholders are urged to attend. This is part of a larger study focusing on Watersheds in five Counties of Southeastern Ohio, including Athens, Gallia, Lawrence, and Scioto, as well as Meigs County.

The meeting will be an opportunity for citizens, organizations, and government officials to identify opportunities, and prioritize watershed concerns, related to flood damage reduction, ecosystem and environmental restoration, as well as other issues relating to water management. Record Stream Sweep Turn Out

The 8th Annual Leading Creek Stream Sweep was held Saturday April 19th at Jim Vennari Park in Rutland, and this year's was arguably the largest ever in the history of the event.

Over 100 volunteers showed up to clean up locations in Rutland and Salisbury townships and in the village of Middleport. Concerned individuals, students and youth groups including 4-H, Girl Scouts and Boy Scouts were among the participants.

We were happily surprised to see the masses of people that cared enough to come out. The 100-plus volunteers that participated this year far outnumbers the 35 who turned out last year. Volunteers filled both of **Rutland Township's dump** trucks and four pickup trucks with trash collected from the stream banks. The refuse weighed approximately three tons.

Volunteers met at 9a.m. and were provided with gloves and trash bags. Locations were assigned and all refuse was to be brought back to the Rutland starting point. For their service, volunteers received a Leading Creek Stream Sweep T-shirt and pizza for lunch.

Many tons of trash and debris have been removed from Little Leading Creek and Leading Creek over the past eight years through this litter clean up. The Leading Creek Stream Sweep coincides with Earth Day and is sponsored by the Meigs SWCD, Rutland Township Board of Trustees, and the Meigs County Transfer Station. This year sponsors also included the Stewart-Johnson Veterans of Foreign Wars Post 9926 of Mason, W.Va.

We would like to thank all the people that helped make this Stream Sweep an amazing success. Plan on joining us again for the Ohio River Sweep on June 21st. See page 5 for details.

Ohio River Sweep 2008

On Saturday, June 21st the 20th Annual Ohio River Sweep will take place. The Meigs Soil and Water Conservation District will organize three locations in Meigs County this year. Volunteers are needed at Pomeroy, Portland, and Racine.

In Pomeroy volunteers meet at the amphitheater in the riverside parking lot. In Racine volunteers meet at Star Mill Park. In Portland volunteers meet at the school that has become the Portland Community Center. At 9am at each site volunteers will begin picking up trash to make the community look a little brighter.

All trash will brought back to the meeting locations and disposed in trucks provided by the villages or townships. Volunteers will then be treated to lunch at noon and receive a new River Sweep T-shirt.

River Sweep is a riverbank cleanup that extends the entire length of the Ohio River and beyond. Some tributary streams are also gradually being added to the list of clean up sites. All counties along the Ohio River participate in this extensive day

camp, but only the first 50 kids will be accepted for this year's two day camp. So hurry up and send in your registration form to the SWCD before May 30th.

Concern Over Local Streams Nothing New

With all the emphasis being placed on watersheds and watershed groups these days, it may be easy to believe that watersheds and watershed groups are somehow a "new" thing.

"Old school" thinking states that creeks and streams should be straight and clean, but by June, 1963, the Meigs Soil and Water Conservation District was already discussing how planting trees could help control flash flooding by slowing down flood velocities and retaining water. The recreational potential of improving watersheds was also considered.

In October, 1963, a letter from the "Citizens Committee for Strip Mining Reclamation in Meigs County" requested assistance from the SWCD in helping solve problems on farms in Scipio Township "which have not been stripped," specifically addressing damage already done to the drainage systems and farm land. The old meeting



minutes do not specify how the problems could be solved, but it seems logical to believe it would involve strip mine reclamation as well as removal of sand from streams.

The board passed a resolution of support requesting assistance from the state, which may have eventually resulted in the reclamation projects of the 1970's and 1980's. Parts of Scipio Township, along with other neighboring townships, were extensively strip mined for coal and much of the sediment from those abandoned mines found its way into streams like Little Leading Creek and Mud Fork, in the Leading Creek watershed, as well as the West Shade River. It is this sand that covers local roads after every flash flood. Some landowners living along those streams are old enough to

remember when the creeks flowed free, and many others can remember the creeks clogged with sand and coal fines so high "you could drive a tractor straight across from bank to bank."

Today, many of those same residents can tell you that things have greatly improved. Reclamation projects have greatly reduced the amount of sediment getting into the creeks, and the sand already in the creeks is slowly working its way down toward the Ohio River.

However, there is still a lot of room for improvement; some creeks still have large amounts of sediment, others are affected by acid-mine drainage from old coal mines, plus there are old, failing septic systems throughout the watershed.
