Coordinates transactions between the parties

Markets export finance programs to exporters and buyers/importers
Works with exporters and International Banks to structure transactions
Communicates banking documentation requirements to buyers/importers
Obtains financial statements and other documentation from buyers/importers
Initiates credit evaluation process and packaging of credit proposal for Exim Bank

US Exporter

Prepares purchase order
Receives payment against shipping documents

Exim Bank

Establishes the rules of the game
Evaluates and approves the credit
Provides credit insurance or guarantee

International Bank

Structures transaction
Evaluates and approves the credit
Funds deal; pays Exim Bank

Buyer/Importer

Accepts purchase order
Sends down payment, usually 15%
Provides credit report and financial statements
Signs promissory notes
