CONDUCT AT ATHLETIC EVENTS: CLV Deputy Marshals Chapter 10.45

It is unlawful for an attendee of an athletic event, which is held within the City to engage in any of the following:

- A. Interfere with, disrupt, or interrupt the athletic event.
- B. Throw any article, including, without limitation, missiles, rocks, bottles, cups, drink glasses, drinking receptacles, and ice, at any of the participants in or officials of the athletic event, or into the area in which the participants and officials are conducting the athletic event.
- C. Discharge any fireworks or firecrackers on the premises of the athletic event.
- D. Enter upon the area in which the participants and officials are conducting the athletic event, when the event is in progress.
- E. Engage in any physical altercation with any of the participants, officials, or other attendees during the progress of the athletic event or immediately after the conclusion of the event.
- F. Injure or destroy any property, which belongs to the facility in which the athletic event is held.
- G. Bring any alcoholic or other beverage, or glass bottles or metal can containers, into the premises, excluding the parking areas, in which athletic event is held. (Ord. 3034 and 3, 1983)

Teams will be affiliated with Nevada State Soccer Association, US Adult Soccer Association, and US Soccer Federation. All game officials must be registered with US Soccer Federation.

WAIVER OF CLAIM

In consideration of the permission granted me to enter the premises and the privilege of participating in the recreation activities, I hereby, for myself, my heirs, administrators, and assigns, release, indemnify and hold harmless, remise, waive, and discharge the Las Vegas Soccer League, the City of Las Vegas and Nevada State Soccer Association, U.S. Adult Soccer Association, their sponsors, agents, employees, representatives or officials from all claim, demands, action and causes of action of any sort, for injury sustained to my person and/or property during my presence on the premises and my participation in the stated activities due to negligence or any other fault, to the fullest extent permitted by law.

In the event the head coach is unable to attend a game or practice, the assistant coach assumes all responsibilities of the team. It is the Head Coach's responsibility to make sure the assistant coach is informed. Your signature certifies that you have agreed to all of the above and your information is true and correct.
