INDIVIDUAL TOURNAMENT ENTRY RULES

Use your highest final sanctioned winter league average, minimum 21 games for the 2008-2009 season.

If your current 21 games average at time of entry is 10 or more pins above 2008-2009 season's average, your current average must be used.

If no average last year, use your highest average at time of entry, at least 21 games. All other bowl scratch, 185 for men, 165 for women.

Non-league bowlers can qualify by paying appropriate membership dues.

Option: Non-sanctioned bowlers pay a participation fee of \$5.00 (USBC) - rule 300c

Possible re-rating depends on winning over \$400 per event within 12 months. This rule applies to all entrants.

G.S.L.A.D. has a right to reject any entry.

Any bowler who falsifies average shall forfeit all prizes and fees.

Report any obvious errors immediately to the tournament chairperson before 9 pm that night.
