## AUSTRALIAN CATTLE DOG CLUB OF NEW MEXICO

**Handler fee: \$60.00 per dog/per day Limit 1 dog per handler Dogs must be entered for a minimum of 2 days Daily Auditor fee: \$20.00 (no dog)**

Clinic limited to 12 dogs of any herding breed. No limit on auditors. Handler or auditor must be at least 18 years of age or accompanied by parent or legal guardian who must sign *Disclaimer Agreement*. Stock work can be done on cattle, sheep or ducks.

Registration, Disclaimer and Deposit due by February 15, 2008. Send handler deposit of 50% or full auditor fee with registration form. Balance due February 22, 2008 on first day of clinic. **NO REFUNDS.** *You are responsible for finding an alternate for days you do not attend.* Confirmation will be sent for all entries by e-mail or U.S. Postal Service. **Directions to clinic on reverse side of this flyer.**

I (we) agree that the club holding the clinic has the right to refuse this entry for causes which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the clinic and the opportunity to have dogs work, I (we) agree to hold this club, its members, directors or officers, and the owner or lessor of the premises and any such employees of the aforementioned parties harmless for any claim of loss or injury which may be alleged to have been caused directly or indirectly to any person or thing while in or upon the clinic premises or grounds or near any entrance thereto. I (we) personally assume all responsibility and liability for any such claim for damages or injury to the dog or property, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause.

I (we) hereby assume the sole responsibility for and agree to indemnify and hold the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this clinic, howsoever such injuries, death or damage to property may be caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
