Balance due February 25, 2008 on first day of clinic. **NO REFUNDS.** *You are responsible for finding an alternate for days you do not attend.* Confirmation will be sent for all entries by e-mail or U.S. Postal Service. **Directions to clinic on reverse side of this flyer.**

I (we) personally assume all responsibility and liability for any such claim for damages or injury to the dog or property, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause.

I (we) hereby assume the sole responsibility for and agree to indemnify and hold the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this clinic, howsoever such injuries, death or damage to property may be caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
