*Scholarship to be awarded to a Roller Skating Association International member's employee or child. The Roller Skating Foundation, Inc. will award one \$2,000 scholarship in both the employee and child categories and one \$1,000 scholarship to a current college student (for the 2009-2010 school year) to applicants who meet the following criteria:*

## EMPLOYEE AND CHILD CATEGORIES

- **EMPLOYEE or CHILD** of a member of the Roller Skating Association (RSA) International. (Includes supplier/manufacturer and coaching member children)
- Will be a college undergraduate during the fall semester of 2009.
- Must have at least a 3.4 grade-point average on a 4.0 scale and have composite score on the SAT/ACT which place the applicant in the 85th percentile or higher.
- **EMPLOYEE APPLICANTS** and thier parents must demonstrate a financial need. Complete tax returns are required.
- Complete application must be received at the Foundation by **March 15, 2009**.

## CURRENT COLLEGE STUDENT CATEGORY

- **EMPLOYEE or CHILD** of a member of the Roller Skating Association (RSA) International. (Includes supplier/manufacturer and coaching member children)
- Currently a college student enrolled for the fall semester of 2009.
- Must have at least a cumulative 3.4 grade-point average and at least a 3.5 grade-point average in Core/Major Concentration on a 4.0 scale.
- **EMPLOYEE APPLICANTS** and thier parents must demonstrate a financial need. Complete tax returns are required.
- Must show excellent leadership qualities.
- Complete application must be received at the Foundation by **March 15, 2009**.
