ADOPTION CONTRACT. In consideration of the receipt of the below said animal, I agree to provide feed, shelter, veterinary care and farrier care to keep said horse in good health and condition.

1. That the horse has been received in good condition to the best of our knowledge, unless so stated below.
2. That the horse will be kept as a barnyard animal and proper care will be provided for it, under Colorado Code 35-44-112 and 35-36-108.
3. That the horse will not be sold, bartered, exchanged, or given away. If the horse is no longer wanted, it is to be returned to MSHR&R.
4. That MSHR&R will be the sole owner of the horse until its death.
5. That MSHR&R will be notified of death, loss or movement out of state of said horse within forty-eight (48) hours of such occurrence.
6. That the horse, its home and quarters can be inspected at the discretion of an officer or agent of MSHR&R, and if the officer or agent feels the horse is not being properly treated and cared for, it may be reclaimed by MSHR&R immediately.
7. That the horse is not adopted for slaughter, livery, or for factory farming.
8. That the horse will not be bred without specific application to MSHR&R, requesting to breed and written consent given by an officer or authorized agent of MSHR&R. A licensed veterinarian must be consulted, both to check for hereditary defects and to ensure that the animal is free from disease and is in good condition prior to breeding.
