WASHINGTON, D. C. — On August 27, 2003, a stone Ten Commandments monument in the Alabama Supreme Court building was forcibly removed from public view by order of a federal judge. This judge ruled that it was illegal for Chief Justice Roy Moore to publicly acknowledge God by displaying one of the foundational documents of American law.

Dr. Alan Keyes — Chairman of the Declaration Foundation, former Assistant Secretary of State under Ronald Reagan, and Republican presidential candidate in 1996 and 2000 — responded: "There has been no law broken here by Judge Moore. This action is unconstitutional and represents judicial tyranny."

As the controversy unfolded, Dr. Keyes called upon all concerned citizens to join him in Montgomery, Alabama, to protest the federal judge's arbitrary order.

"I will be there," he said on national radio and television.

And he was there — over a two week period, as he addressed rally after rally, often late into the night. Dr. Keyes inspired those thousands who converged on Montgomery to stand up for God in our nation's civic life.

"We have reached the final stage here" in America's future, Dr. Keyes told Sean Hannity's national radio audience at the outset of the crisis. "The federal judges are trying to rip the Ten Commandments from the heart of this country. It is the final stage in decades of assault on the moral foundations of America. The judges are acting in a lawless fashion, and it is time that we looked them in the eye and told them we won't stand for it."
