Recoup of League Meeting – update from Kelly Malone

-There are two new league teams in division 2- Wenatchee and Three Rivers. These two teams are hosting a tournament in April.

-Team Rosters are due to Sportability by March 1st – to post assigned jersey numbers

-The league dues are \$7.00 per player – we need to notify the league if a game is cancelled or we will have to pay the fees.

Team Washington LaCrosse- Competes on a National level. Once you are on the team it is free to the player – all expenses including travel, uniforms etc. will be paid for by Team WA LaCrosse. Players are nominated by their coach for a free try-out for the team in June. The top 20 high school players are chosen.
