#### **Pumpkin Ice Cream Torte with Ginger Crust**

from SUNSET MAGAZINE, November 2001

8 ounces crisp gingersnap cookies
2 tablespoons sugar
3 tablespoons butter or margarine, melted
1 can (15 oz.) pumpkin, chilled
2 teaspoons pumpkin pie spice
About 1 1/4 cups caramel ice cream topping
1 quart vanilla ice cream, softened (see notes)
About 1 cup hot fudge sauce or chocolate ice cream topping
Candied Walnuts

Place about a third of the cookies in a zip-lock plastic bag, seal bag, and roll with a rolling pin until cookies are finely crushed; pour into a 9-inch cheesecake pan with removable rim (at least 2 in. tall). Repeat to crush remaining cookies (you need 1 3/4 cups total) and pour into pan. Add sugar and butter and mix. Press cookie mixture over bottom and about 1 inch up sides of pan.

Bake crust in a 325° regular or convection oven until lightly browned, 10 to 12 minutes. Let cool about 5 minutes, then chill or freeze until cold, 5 to 10 minutes.

In a chilled large bowl, mix pumpkin, pumpkin pie spice, and 1/4 cup of the caramel topping until smooth. Add ice cream and mix until blended. Working quickly, spoon about a third of the ice cream mixture into the cold crust. Drizzle with 2 tablespoons caramel topping and 2 tablespoons fudge sauce (if fudge sauce is too stiff, warm slightly in a microwave oven at full power (100%), stirring once, just until fluid, 15 to 30 seconds); sprinkle half the Candied Walnuts on top. Repeat with two more layers, omitting nuts on the top layer.

Freeze until solid, about 5 hours, then cover and freeze up to 1 week.

About 15 minutes before serving, remove sides from pan, set torte on a serving plate, and let stand in refrigerator to soften slightly. Cut into wedges. Serve with additional caramel topping and fudge sauce (warm and stir again if too stiff) to add to taste.

Yield: Makes 12 servings

#### **Shoreline Stitchers' Showcase**

Last month, I wrote about the fundamental purpose of our Shoreline Stitichers' Showcase. This month, and for several succeeding months, I will write about the expenses.

Since one of the purposes of the Showcase is to advance needlework as an art form, we have classes in our exhibit for all kinds of needlework done by hand with a threaded needle. We do not limit entry to just counted pieces or canvas work like the ANG National Exhibit. With the exception of the Masters Division, the Divisions and categories are very similar to those at National, but the classes reflect the different types of needlework created by our exhibitors. As long as we continue to receive sufficient entries for a particular class to make class formation meaningful, we will continue to have those classes. When it becomes clear there is not enough local interest in a particular class, we'll drop it from our Entry Form and Judging criteria. Likewise, if some type of needlework without its own class becomes popular, we would consider splitting it off into its own class. The main advantage to separating work into classes is so that similar techniques may be judged together without competition from substantially different techniques. For instance, Japanese Embroidery does not have very much in common with Crewel, and both would suffer from comparison to each other. Petit point and Needlepoint have a great deal in common, with the exception of size of ground, but there are more than enough of each to warrant separate Classes. Counted Samplers are another group large enough to separate from other types of counted pieces. There are also advantages to having more, rather than less classes because exhibitors like to get ribbons and smaller classes makes this more likely. Happy exhibitors will come back and exhibit their work with us again.

Another key point is the "diverse and competent authority"; this refers to the Judging staff and the judging in general. We resolved to hire only ANG, EGA or NAN certified judges to ensure competency. We also want exhibitors to receive comments from a range of judges; therefore we do our best to not hire the same judges Showcase after Showcase, or more than one of the same judges as EGA Channel Islands uses for their exhibit. These two "rules" combine to make Judging the most expensive item associated with the exhibit. Certified judges receive compensation of \$150 to \$200 per day of judging, and we hire three judges for three days. If you look at the list of ANG certified judges in the back of your ANG Education Guide, you will see very few of these judges live west of the Mississippi. Anyone who travels today by any type of transportation knows how expensive this is, and people's lives and other commitments affect their availability. I was fortunate to be able to hire two judges for the first Showcase who live somewhat near to LA and we only paid for air transportation for one judge. The 2008 Showcase required airfare for two judges. All three judges need to be housed and fed for 4 nights, and this is LA, so you see it adds up.
