To a needlepointer, these words are instantly recognizable as naming Jean Hilton's stitches. Along with the "Mistake" stitch, the "Chilly Hollow" stitch, and many others, Jean's inventive mind created a whole world of geometric stitches to challenge us and take our projects in a new direction. With Jean's passing in early May, the stitching world lost a spirit who was very influential in the last 30 years.

Circles and curves are always challenging for needlepointers to create, because our canvas is full of holes that are placed in horizontal and vertical rows, making it difficult to make a smooth curve in a small area of canvas. Jean's gift was to take straight stitches and arrange them in such a way as to end up with a curve; not just any curve, but a beautiful curve that is pleasing to the eye.

Back in the 1970's there was a craft that I believe was called "string art." Nails were placed at regular intervals on a velvet covered board. The art was constructed by wrapping string around the nails to form pleasing geometric shapes. I remember making a sailboat with a toy hull, a dowel for a mast, and gold thread. (It must have been awful.) I, and apparently everybody else, was unable to make the leap that Jean did; she transferred these parabolic stitches to canvas. Her techniques are non-traditional and innovative.



In 1989 -1990, Jean designed several (11?) chapter patches for various ANG chapters. Needle Artists by the Sea was one of these lucky chapters, and Jean herself taught the patch at the guild's annual luncheon and project in November 1990. The picture at the left shows this special design. Patterns for our NAS Chapter patch are available for \$5 from Mary Ellen Bell. Why not stitch one in honor of Jean and all her contributions?

Jean Hilton's teaming up with John Schatteles of Rainbow Gallery was a fortuitous happening for our stitching world. Her imaginative designs and his array of fabulous fibers did much to take needlepoint to new heights of creativity,

spontaneity, and just plain fun. Four of her smaller designs are available as free downloads from the Rainbow Gallery website. Additionally, Stitches from the Heart, in Indiana has her full collection of designs and books.

For a moving tribute to Jean, please read Yoyo's post "Leaving a Legacy, June 9, 2009" on her website http://dragonmyneedle.blogspot.com. That several other designers are still creating in the same style speaks volumes that Jean's vision will endure. We are fortunate to have Jean leave us a large legacy of patterns and stitches. She will be celebrated by so many stitchers who will enjoy her creations in the future.

Ultra Suede Sequins

Small pieces to match fish colors 3 mm fully cupped – 2 shades (available from ccartwright.com)

size 15/0 Glossy black, Seed beads one main fish color and two

additional shades to complement

the main color

Felt Small pieces to match fish colors Black eye beads

2 beads [3mm for canvas

2mm for congress cloth]

size 12 and 13

Size B to match fish colors

Beading needles Nymo Beading thread

Black sewing thread

Wax Scissors Working surface

SPECIAL NOTE: The chapter has purchase some blue, green and gray sequins as well as ultra suede for those that would like it. There should be enough for everyone as long as everyone does not pick the same color. FREE WHILE SUPPLY LASTS. We will not reorder!

NAS Standing Rule Review

Please take a moment to read through the Standing Rules at the end of your 2009 roster. If you have any questions or suggestions for changes, please pass them on to Fran Lambert, our Historian, who will be heading up this review cycle.

Shoreline Stitchers' Showcase

The Showcase calendar presents its own challenges. The Committee needs to meet to start preparation at least a year in advance of the Showcase. This is when the facility contract is signed and a deposit is made. We set the date of the Showcase, and work backwards from there to establish dates for judging, for drop-off and for entry forms to be due to the Showcase Administrator. Judges need to be hired in this time frame to make sure we are on their calendars well in advance of their making plans for their own lives. Then nothing much happens until 5 to 6 months before the Showcase, when things start speeding up.

The Entry brochure needs to be prepared, printed, mailed and distributed to shops along with posters. Various ads need to be placed with other Guilds to publicize the Exhibit for entries. Advertising space in the program needs to be sold to sponsors. Boutique merchandise is solicited, collected, priced and stored until Set-up day. Special Event insurance and supplies are purchased, the special ribbons are ordered and judge's favors are stitched. Incoming entries need to be processed, entry fees deposited and bills paid, judge's accommodations arranged, including their transportation and hospitality.

Drop-off is scheduled for over a weekend. Exhibitors prefer to have their pieces out of their hands for as little time as possible, but the time between Drop-off and Set-up really needs to be about 3 weeks to accommodate everything that needs to be done.

The Judges usually come into town the afternoon or early evening of the day before actual judging commences, and a few of the Committee and the Judges have a dinner meeting to get to know each other and to acquaint the Judges with the general plan for the next three days. Hopefully, the Judges have conferred on their judging methodology before arriving; so far this has resulted in an entire class being presented as a whole where they can get a general impression of the collected works, and then the Judges examine each piece in more detail. All three judges reach consensus on the placing of a class and one of the judges writes up the consensual comments. Ties are certainly allowed. We have lots of ribbons. The program is prepared and printed and the winning pieces are photographed after judging ends.

The Judges take as long as they need to get a class placed appropriately and to give at least one insightful comment on each piece. The volume of entries and short time available for judging does not make this easy. Even in the smaller second Showcase, the Judges needed to look at, place and comment on 244 pieces in three days. If they worked an 8-hour day this gives them just under 6 minutes per piece to judge the whole Showcase. Clearly, they and the Showcase staff assisting with the judging worked a lot longer than 8 hours each day.

Next month I'll go into more detail about the actual judging process. As always, if you have any questions please call me (number in the roster) or email and I'll answer as soon as possible.
