GRAD NIGHT RULES

1. Students are expected to follow all rules set forth by the Grad Night Committee and its volunteers.
2. Students will ride on the event-sponsored bus to and from Oak Ridge to Sunsplash. **No student will be allowed to drive themselves or others to this event. Any student arriving by other than event-sponsored transportation will be denied entrance to the event.**
3. All students will be subject to bag check at check-in. All bags will be checked for drugs, alcohol, and other substances. **NO LIQUID OF ANY TYPE ALLOWED.** All illegal or disallowed items will be confiscated at check-in.
4. Parent(s)/guardian(s) will bear all costs incurred as a result of property destruction by their student.
5. All participating students must have a completed permission slip on file. Signature of a parent on this permission slip verifies parental permission and agreement with the rules of the event.

MEDICAL RELEASE

I, (we), the undersigned parent or guardian of the above named Oak Ridge senior, 2007, do hereby authorize the members of the Grad Night Committee, representative(s) for the undersigned in our absence, to consent to x-ray examination, anesthetic, medical, or surgical treatment or other hospital care which is determined advisable in an emergency situation. Such treatment or care is to be provided by a physician or surgeon licensed under the Medical Act at the office of said physician or any duly licensed medical facility. It is understood that this authorization is given in advance of any such event, but is given to provide authority to Grad Night Committee members/volunteers. This authorization is given pursuant to the provisions of Section 25.8 of the Civil Code of California. The undersigned agrees to bear all costs incurred as a result of any medical treatment deemed necessary by a licensed physician. This authorization will remain in effect for the duration of the event. Including, but not limited to, transportation to and from the event.
