<p>HIS PHYSICAL CONDITION. 4/610/01 PERIODICALLY HE COULD NOT SLEEP WITH THE ABOVE PROBLEMS. S/GIBSON ALSO COMPLETED A PRELIMINARY ALCOHOL SCREENING TEST WITH RESULTS OF .12% .12.3% B.A.C. (F.R. ATTACHED). IT WAS DURING THE SPRING MONTHS HE DRINKED. AND HE WAS DRINKING IN EXCESS OF 23152 (TWO THOUSAND THREE HUNDRED FIFTY-TWO).</p> <p>S/GIBSON WAS COOPERATIVE WITH THE FIELD INVESTIGATION. HIS CONDUCT BEGAN TO CHANGE WHEN IT ADVISED HIM HE WAS BEING DETAINED/ARRESTED FOR DRUNK DRIVING. KICK PLATE GRAY OF THE VEHICLE. RV-1
