#### AGREEMENT REACHED IN THE FEDERATED RANKS COMMITTEE

- 1. At the meeting of the Federated Ranks Committee on 15 July 2004, agreements were reached on :
  - (i) the pay of federated ranks;
  - (ii) dog handler's allowance
  - (iii) Competence Related Threshold Payment
  - (iv) PSNI Allowance; and
  - (v) Temporary non-pensionable supplement for inspectors and chief inspectors in the PSNI.

Details are set out in the attached memorandum and annexes.

#### **MEMORANDUM**

The following agreements reached in the Federated Ranks Committee of the Police Negotiating Board are submitted for the approval of the Secretary of State for the Home Department, the Scottish Ministers and the Secretary of State for Northern Ireland.

# 1. <u>Pay</u>

To increase salary rates for federated ranks as set out in Annexes A, B, C and D.

## 2. Dog handler's allowance

To increase the annual rate of this allowance from £1,761 to £1,815 with effect from 1 September 2004.

## 3. Competence Related Threshold Payment

To increase the annual rate of this allowance from £1,002 to £1,032 from 1 September 2004.

## 4. PSNI Allowance

To increase the annual rate of this allowance from £2,577 to £2,655 with effect from 1 September 2004.

# 5. <u>Temporary non-pensionable supplement for inspectors and chief inspectors in the PSNI</u>

To increase the annual rate of this allowance from £4,260 to £4,389 with effect from 1 September 2004.
